IN THE NAME OF THE COMMONWEALTH OF MASSACHUSETTS, YOU ARE HEREBY DIRECTED TO NOTIFY AND WARN THE INHABITANTS OF SAID TOWN QUALIFIED TO VOTE IN ELECTIONS AND TOWN AFFAIRS TO MEET AT FAIRBANKS MEMORIAL TOWN HALL, 32 MAIN STREET, ASHBURNHAM, MASSACHUSETTS ON

THURSDAY, THE TWENTIETH OF OCTOBER, 2005 BEGINNING AT 7:00 P.M.

THEN AND THERE TO VOTE ON THE FOLLOWING ARTICLES AND RESOLUTIONS:

Article 1. To see if the Town will vote to appropriate by transfer from available funds a sum of \$30,000 from the Water Surplus account and raise \$100,000 from abatements, for the design and construction of a water line in the Page's Beach area, including but not limited to replacement of existing water lines and all engineering, legal and grant administration costs associated with such water line, and to authorize the acquisition by purchase, eminent domain or otherwise any fee, easement or other interest in land necessary therefore and to authorize the Board of Selectmen to acquire such interests, and to enter into any and all agreements necessary to carry out this project on such terms and conditions as may be in the best interest of the Town, and further that to pay for all or a portion of the costs associated with this project betterments shall be assessed under Chapter 80 of the Massachusetts General Laws; said funds to be used to supplement funds received under the Community Development Block Grant Program, or act in relation thereto. (Requested by the Board of Selectmen)

To see if the Town will vote to appropriate by transfer from the Chapter 90 account a sum of \$34,253 to pay for the first year of a three-year lease with an option to purchase a 2006 truck with sander and plow for the Highway department and to authorize the Town Administrator to enter into a lease with an option to purchase for a term of three years for such vehicle, or act in relation thereto. (Requested by the Town Administrator)

To see if the Town will vote to appropriate by transfer from free cash a sum of \$26,219 to pay for the purchase or first year lease, of computer servers, desktop computers, screens, printers and related peripherals and software as well as the consulting services related to the installation and operation of all hardware and software, for the purpose of replacing the Assessor's current computer system, and further to authorize the Town Administrator to enter into a lease agreement, to fund the purchase of said equipment and services, for a period of up to four years, or act in relation thereto. (Requested by the Board of Assessors/Town Administrator)

(Requested by the Ashburnham-Westminster Regional School District)
