Attached request from City Manager; Doug Selby and Director of Municipal Utilities;
 Vicky Murphy for job changes at the Waste Water Treatment plant. Requesting to add the job title of WWTP Operator #2 in the competitive class.

Vicky Murphy reviewed the New Position Duties Statement that was presented to the commission and explained the reason this position is needed now is that the Engineering Dept. used to handle the added job duties but since a recent retiree we have been paying an individual out of title to accomplish those duties. Commissioner DeAngelis requested if any further documentation was turned in. He would like an overview of why the change is necessary. Secretary Fulton reviewed the process of adding a new job and the different levels of jobs at the WWTP. Discussion was had in regards to the education and experience requirements.

Commis. DeAngelis questioned why a HS diploma is listed for education but in experience mentions an Associates degree. The Commission requested clarification on that. More discussion was had in regards to the 3A and 4A licensing and who needs to have them at the plant. Commis Brennan questioned if a decision needs to be made today. John Rossi suggested the sooner the better as we are paying someone out of title. Commissioner DeAngelis requested more detailed information. Will Streeter questioned is this reclassification because it is a current employee or adding a new position. Commissioner Jack Hardy motioned to table the discussion until we can receive further documentation on the reason for the new job, the education and reclass vs new position. Motion 2nd by Commis. DeAngelis. Motion carried 3-0.

 Also requesting **bolded** job description changes to the description of Building Maintenance Mechanic.

Commissioner DeAngelis questioned how many building maintenance mechanics are in the city and questioned why you would change a general job description like this just to fit duties at the WWTP. Under min quals you added the experience in the landfill and gas operations. If this position was vacant it would be difficult to fill with those requirements. Commis Brennan thought it was ok to add those specifics because the only place we have building maintenance mechanics is a the WWTP and those duties represent what they do at the plant which are unique to the city. Discussion was had if it should be a new position or just added duties to the current Building Maintenance Mechanic. Secretary Fulton expressed that if you make a new position it will be a competitive job and exam will be ordered as opposed to this title which is non-competitive. The commissioners agreed that the year of landfill for gas operation experience should be removed. Secretary Fulton reviewed that if the City Manager were to assign a new grade for this title all new building maintenance mechanics would be hired at this new grade all preforming the same duties. Commissioner DeAngelis stressed again that it the title seems to generic for such specific duties. Commissioner Hardy motion to make changes to the Building Maintenance mechanic position that Vicky Murphy suggested except eliminating the one year landfill or gas operations requirements. Commis. DeAngelis 2nd the motion. Motion carried 3-0.
