Chairman Christopher DeAngelis called the meeting to order at 3pm and read the Notice of Public Hearing. Civil Service Clerk Anna Hlywa took the roll call: Commissioner DeAngelis, Commissioner Gove and Commissioner Hardy present. Commissioner DeAngelis read the attached Amendment to Appendices of Auburn Municipal Civil Service Rules and Regulations. Commissioner DeAngelis opened the Public Hearing to place the title of General Mechanic/Heavy Equipment Operator in the Non-Competitive Class.

Superintendent of Public Works, Mike Talbot spoke in favor of General Mechanic/Heavy Equipment Operator position in the non-competitive class. He stated that this position like all the positions in the Public Work Department have various duties and a multitude of tasks all from different aspects. It would not be practical to test for. Also, hardly any of the Public Works jobs are Competitive and I believe that this job falls in line with most of them. Will Streeter, The CSEA representative also spoke in favor of the General Mechanic/Heavy Equipment Operator in the Non- Competitive class. Mr. Streeter noted that this job will not have supervisory duties and is line with other Non-Competitive class positions in PW. At this time Chairman DeAngelis asked if anyone else desires to speak at the Public Hearing. No other input was given. Chairman Chris DeAngelis confirmed that this local Commission agrees that it isn't practical to test for this position based on the range of duties the incumbent is required to perform. We believe testing would not be practical. Kept the floor open of the Public Hearing in case anyone showed up late or had any other input. Commissioner DeAngelis again requested if anyone had any comments or input. No other input on the Public hearing. Chairman Chris DeAngelis closed the Public Hearing read the attached resolution to amend the Appendices of the City of Auburn Civil Service Rules. Commissioner Hardy motioned to send the resolution to the State to approve placing the General Mechanic/Heavy Equipment Operator in the Non-Competitive class. Commissioner Gove 2<sup>nd</sup>. Civil Service Clerk, Anna Hlywa took the roll Commissioner Gove - Yes, Commissioner Hardy - Yes, Commissioner DeAngelis – Yes. Resolution is adopted.
