Request from City Manager to fill Vacant Clerk position in PW

Attached memo from Doug. First step is to canvass comparable titles from the preferred list. Motion by Commissioner Gove to canvass the position of Parking Garage Supervisor as she believes there are enough comparable duties from that position to the Clerk position. 2nd By Commissioner Emmi. Motion carried 3-0. A canvass letter for the Clerk position will go out the recipient who has 5 business days to respond. Also the position of Economic and Program Manager is on the preferred list. Discussion was had if the Parking Garage Super responds no or does not respond would that laid off employee be eligible for a canvas. Commissioner Hardy spoke that the believed enough comparable duties exist and that the position should receive a canvass. Motion to canvass the Program Manager for the Clerk position by Commissioner Hardy, 2nd by Commissioner Emmi: Commissioner Gove, No (not enough comparable duties), Commissioner Emmi: No, Commissioner Hardy: Yes – Motion not carried. The Program Manager is not considered comparable to the Clerk position.

Jenny Haines explained the domino effect to all these jobs that may become vacant once the first one is filled. All the positons are competitive and we have an active preferred list so these steps need to be followed.

Motion to canvass the Admin Assistant from preferred list to fill the vacant position of Secretary upon the transfer made my Commissioner Gove, 2nd by Commissioner Hardy. Motion Carried 3-0. Motion to Canvas the Parking Garage Supervisor for the vacant Admin Assistant and Keyboard Specialist opening as the vacancies occur by Commissioner Gove, 2nd by Commissioner Hardy. Motion carried 3-0. Motion to canvass the Economic Program Manager positon for the Secretary & Keyboard Specialist vacancies as they occur by Commissioner Hardy, 2nd by Commissioner Emmi. Commissioner Gove: No , Emmi: No Hardy: Yes, Motion not carried. Positon not deemed comparable enough for reinstatement without further examination.

• Request from City Manager to reinstate retired employee to PT Secretary of Planning and Economic Development.

Motion to reinstate retired employee to PT Sec to Planning & Economic Development by Commissioner Gove, 2nd by Commissioner Hardy. Jenny Haines explained that we canvassed the preferred list, the promotional and open competitive list. Due to the PT status we are left with non-mandatory list and reinstatement of a retiree would fit the office well. Motion carried 3-0.

 Request from City Manager to change the Custodian Job at the Police Department to Laborer Job

Lengthy discussion was had in regards to the job duties of the soon to retire Custodian at the Police Department and the duties of a Laborer. Commissioner Gove stressed that the job classifications and duties are extremely different and the incumbent that is appointed this job may be working out of title if you ask him to mop the floor or clean a toilet. Superintendent of PW Mike Talbot & Chief of Police Brian Neagle spoke in regards that this is a necessity as a custodian is limited to just that work of inside janitorial duties. They would like someone to clean the driveway, shovel snow, light maintenance duties inside and outside the building. Commissioner Emmi Motioned to approve the request to change the position at the Police Department from a Custodian to a Laborer. 2nd by Commissioner Hardy. Commissioner Gove: NO, Commissioner Hardy: Yes, Commissioner Emmi: Yes. Motion Carried.

Certify Eligible list #62-185 General Mechanic/Heavy Equipment Operator
Motion to certify list for 4 years by Commissioner Gove 2nd By Hardy Motion
Carried 3-0. This positon has a provisional appt. in place. The incumbent needs to be
