City of Auburn City Council Meeting Minutes August 25, 2011 4:30PM

The regular meeting of the Auburn City Council was called to order at 4:30PM in City Council Chambers, 24 South St. Auburn NY by Mayor Michael D. Quill.

Roll Call – The City Clerk called the roll: Councilor Graney, McNabb, Brower, and Mayor Quill, all Present. Councilor Smith absent.

City Staff Present: Corporation Counsel, and Interim City Manager John Rossi, Debra A. McCormick, City Clerk, William Lupien, Engineering Superintendent, Vicky Murphy, Municipal Utilities Director, Police Chief Gary Giannotta, Mike Talbot, Public Works Supervisor.

The Mayor led the Pledge of Allegiance and asked for a Moment of Silence

Public to be heard

Jack Hardy, 72 Chapman Ave. spoke to announce the third annual "Back to School - Stay in School" event to be held at Booker T. Washington Community Center on Chapman Ave. Auburn Police will have a K9 demonstration; Auburn Fire Department will have fire safety tips and information. It will be held on Saturday from 2-5pm. Many local businesses have donated school supplies and more to make the event a success.

Jerry Morgan, Standard Woods Apt. spoke to ask the Mayor to recall a conversation they had several years ago regarding funding for new fire trucks.

Pete Rusika Walnut St. commented on the agenda being posted online. He stated that too much time is being spent on issues like the minutes when other bigger issues should be addressed. He asked why the budget was not on line.

City Manager's Report- John Rossi acknowledged city employees that would be receiving certificates of recognition from the New York Conference of Mayors for years of service.

Mr. Rossi congratulated the Auburn Public Theater and the Merry Go Round Theater for their successful summer theater festival 'trial run' show "The Calamari Sisters". It is reported that over 8000 people from all over central New York attended the show.

Mr. Rossi also reported that Councilor Brower has asked him to have an independent inquiry done related to the allegations of impropriety that have been brought up by an Auburn citizen. He has retained Richard Zwirn, an attorney in Moravia with no political ties to Auburn. Corporation Counsel is confident that a thorough and fair review will be done.

Mr. Rossi invited Carey Eidel, Executive Director of the Auburn Public Theater to speak. Mr. Eidel thanked Council for amending the ordinance. He spoke briefly on how the theater has grown since it began in 2005 and the positive impact that it has had on the community economically and culturally.
