Kathleen Morgan Standart Woods spoke to Council about the problem of this product being sold to teenagers.

#### Other Business

**City Manager, Doug Selby** presented Council with a Budget Update through January 31st that included a look at the trends over 5 years in each city fund. Council discussed.

Councilor Ruzicka asked the Mayor if he could replace him as a board member on the Auburn Municipal Power Agency board and questioned the Mayor's attendance at the AMPA meetings. Mayor Quill remarked on changes made to the day of the monthly meetings, and previous commitments that had an impact on his ability to attend. He declined Councilor Ruzicka's offer to replace him and also explained that the bylaws of the board require the Mayor to serve.

Councilor Smith requested and update on the status of clean up at the Dunn and McCarthy site. Mr. Selby responded with the immediate plans which included the possibility of a community garden. Long term plans will depend on soil testing and other environmental regulations.

Councilor Smith commented on the ongoing discussion regarding the Cayuga Ingredients project and the City's position and public perception.

Council adjourned to executive session at 7:15PM and returned at 7:25PM.
