### **Local Law**

The Clerk read for the record the first reading of Local Law #1 of 2012 providing an exemption from real property taxes as authorized by Section 485-a of New York Real Property Tax Law.

Councilor Smith commented as he has been the advocate for pursuing this exemption.

The SEQR resolutions voted on earlier in the meeting were tabled legislation.

#### Other Business -

The City Manager presented preliminary figures for the 2012-13 City Budget. Council discussed. He gave an overview of revenue and expense numbers. He also suggested an idea that could raise revenue by implementing an annual trash fee that would charge per dwelling unit. He explained the details - that heavy users would be paying their share while, those that only have one bag of trash would not be subject to the addition cost. Council discussed the idea and why they did not favor such a plan.

Council agreed to meet on the 5th Thursday of May to continue work on the Budget.
