### **Presentations and Proclamations -**

**Consolidation of Water and Sewer Service** - Stephen Waldvogel, Conestoga-Rovers & Associates P.E and Dan Spitzer, Attorney, Hodgson Russ, LLP presented Council with a status update on the Cayuga County Regional Water and Sewer Consolidation Analysis. The presentation included:

- A summary of effort from 2010 through 2012
- Review of rate deliberations
- Review of physical system evaluation findings

Councilors and the consultants discussed the project in detail for over 90 minutes.

**Improvements for Brogan Manor- Request for PILOT** - Stephanie Hutchinson, Executive Director Auburn Housing Authority and Robert Bergan, Attorney for organization presented Council with a brief history of Brogan Manor and the community that it serves. They outlined the needs and cost to maintain buildings, appliances, utilities and quality of life in the homes. They asked Council to consider a 40 year PILOT agreement to allow Brogan Manor to continue service as an affordable housing option in the city.
