The meeting of the Auburn City Council was called to order at 6:00PM in the City Council Chambers 24 South St. Auburn NY by Councilor Camardo.

Roll Call – The City Clerk called the roll. Councilor McCormick, Camardo, Cuddy, Ruzicka were all present. Mayor Quill was absent/excused due to illness. Mayor Quill asked Councilor Camardo to fill the role of Presiding Officer.

City Manager's Report - The City Manager reported:

- On the issue of NYSEG reporting to the City that they will be flying helicopters at low levels above the City on Friday, March 7, 2014
- On the issue of the City's new Comptroller Laura Wills. The Manager reported that the
 new Comptroller is hard at work on many different topics. She has been working with
 City Department Heads and purchasing personnel on making necessary decisions to
 improve City purchasing procedures and properly define budget lines for the upcoming
 City budget preparation.
- On the issue of the new turbine being installed at the Mill St. Dam. The Manager invited Director of Engineering William Lupien to provide an update on the upcoming turbine installation.

Councilor Camardo made a Motion to Table Financial Resolution #43 of 2014, the Motion to Table was seconded by Councilor Ruzicka. The Motion to Table was defeated 2-2. Councilors McCormick and Cuddy voting no. Councilors Camardo and Ruzicka voting aye.

Council discussed.

Councilor Camardo made a Motion to Amend Financial Resolution #43 to reduce the amount to transfer to the Water Fund Revolving Loan Account #HF 99.503.002 from

\$375,000.00 to \$25,000.00. The amount of \$25,000.00 will provide enough funding for projects that come up over the next few weeks. Councilor Ruzicka seconded the Amendment. (See Attachment A) The Motion to Amend carried 3-1. Councilors McCormick, Camardo, and, Ruzicka voting aye. Councilor Cuddy voting no.

Council discussed.

The Council then voted on the Motion to approve Financial Resolution #43 as amended. (See Attachment B) The resolution carried 4-0. Councilors McCormick, Camardo, Cuddy, and, Ruzicka all voting aye.

I. Council Resolution #44 of 2014 Authorizing a Special Loan Program from the Water Revolving Loan Fund At 0% Financing

Motion to approve sponsored by Councilor Ruzicka, seconded by Councilor McCormick. The resolution carried 4-0. Councilors McCormick, Camardo, Cuddy, and, Ruzicka all voting ave.

Motion to approve sponsored by Councilor McCormick, seconded by Councilor Cuddy. The resolution carried 4-0. Councilors McCormick, Camardo, Cuddy, and, Ruzicka all voting aye.

Other Business

- Councilor McCormick reported on the March 1, 2014 Owasco Lake Symposium.
- Councilor McCormick reported that she and Councilor Cuddy attended a Saturday,
 March 1, 2014 a meeting with Congressman Dan Maffei. The purpose of the meeting
 was to discuss infrastructure needs. She thanked the following City staff for also
 attending this meeting: City Manager Selby, Christina Selvek, Anthony DeCaro, and Bill
 Lupien.
- Councilor Cuddy has four requests: 1. That the City Manager prepare a report that can be presented to the Council at the March 13th Council meeting that gives an accurate accounting of our Water Fund and how the use of various amounts of fund balance would impact the fund over the next 3-5 years. 2. That another bond ordinance similar to Bond Ordinance #1 of 2014 be brought before council. 3. That the City still apply for the State EFC loan program for the Water Filtration system upgrades even though the application will arrive late. 4. That the Council pass a resolution urging our State Representatives and Governor Cuomo to end the Gap Elimination Adjustment in the State Budget which takes away a portion of state aid from school districts to fill the State's own budget shortfall.

- Councilor Ruzicka praised and congratulated the Auburn High School Ice Hockey Team on their recent success. He commented on their game on March 1, 2014 and that the game and our City's Casey Park Ice Rink brings many people to town from elsewhere and that this is good for the local economy. He wished the High School Ice Hockey team well as they travel to Utica, NY the weekend of March 7-9 to compete for the State Championship.
- Councilor Ruzicka suggested that there be an individual, perhaps the Comptroller, that would sign off on financial resolutions that come before the Council.
- Councilor Cuddy joined councilor Ruzicka in congratulating the Auburn High School Ice Hockey Team. He also asked that the City convene a meeting of all interested parties that use the Casey Park Ice Rink. The purpose of the meeting would be to discuss the costs associated with operating the Rink and how to pay for those costs.
- Councilor Camardo also congratulated the Auburn High School Ice Hockey Team.
- Councilor Camardo asked that the Council consider following the lead of Syracuse Mayor Stephanie Miner and lobby the State of NY for more infrastructure money to be provided to municipalities for infrastructure needs.
- Councilor Camardo would like a follow up on his request from a week ago to individually review the repairs needed at the Water Treatment Facility and make a plan to determine how those repairs could be funded with existing funds.
- Executive Session. Council voted to enter an executive session regarding matters pertaining to:
 - 1. Contract negotiations (NYS Public Officers Law, Article 7 §105-e. Collective negotiations pursuant to article fourteen of the civil service law);
 - 2. Matters pertaining to the appointment of particular individual. (NYS Public Officers Law, Article 7 §105.1.f. The medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation.)

Motion to enter an executive session was made by Councilor McCormick, seconded by Councilor Cuddy. The motion carried 4-0. Councilors McCormick, Camardo, Cuddy, and Ruzicka all voting aye. Council entered into executive session at 7:45 p.m.

Council returned from executive session and by unanimous vote adjourned the meeting. The meeting was adjourned at 9:15 p.m.
