# **City Manager's Report** – The Manager reported on the following:

- The Manager introduced Paul Tennity from Erdman Anthony engineers. Mr. Tennity is the resident engineer on the Franklin Street reconstruction project. The Council asked questions and discussed the issues pertaining to the project and the impact it had on Franklin St. residents.
- The City has been attempting to deal with the problem of algae growth at the Hoopes Park pond. Last year the city spent money and resources to dredge the pond. Even after the dredging the algae is back this summer. The city is testing the water to try to

- determine the source of the problem. The city has also introduced 30 grass eating carp to the pond to try to keep weed growth under control. City staff will continue to work on this issue and report to Council.
- The new contractor that is running the city Co-Gen facility has determined that the heat exchangers at the Co-Gen plant should be removed. This will hopefully produce greater operating performance at the facility. The heat exchanging equipment will be placed into storage.

### **Other Business**

- **A. Review of the proposed Management Policy.** The City Manager discussed his proposed Management Ordinance. Council discussed. A request was made to add a list of the affected job titles into the document. It was decided that the Council would vote on the matter at the next Council meeting.
- **B. Discussion of Proposed Organizational Changes.** The City Manager introduced the topic because of the fact that different ideas were discussed during the budget process. The Manager would like Council input and ideas to be discussed now for future implementation and decision making. The Manager offered up one organizational change he is looking to make immediately which would move senior services from the Department of Public Works to the Department of Planning and Economic Development. The Council members discussed different ideas they

have pertaining to the issue. There was a consensus among Council that ideas should be sent to the City Manager and that the topic could be scheduled for future Council agendas for more in depth discussions.

## C. Discussion of Council Rules and Procedures

The City Clerk discussed that earlier in the year the Council began a review of the City Council Rules and Procedures. The revision of the Council Rules and Procedures that the Council tabled on April 3, 2014 has been included in the agenda packet.

It was decided two weeks ago that any input Councilors had to the rules and procedures should be sent to the City Clerk. The Clerk reported that input was received from Councilor Ruzicka and the Clerk e-mailed his edits to the Council earlier in the week. After Council discussion a majority of Council members stated they would like to vote on the document as proposed and it was decided that the document would be brought before the Council for a vote.

- **D.** Councilor Camardo asked that when the Council commits to responding to residents that come to Council meetings that the Manager follow up with the Council to report on how the issues were resolved. He also discussed the issue Mr. Ferrara from easterly Ave. brought up a few weeks earlier to Council about his situation with parking on Easterly Ave. The Council discussed the matter and a memo that the Police Chief and Traffic Control Officer provided on the matter. It was decided by a majority of Council to take the recommendation of the Police Chief's memo.
- **E.** Councilor Cuddy brought up the topic of developing a grading system for city vendors and contractors. The Manager and Council discussed. Councilor Camardo stated that the issue lies with enforcing the contracts we have with contractors.
- **F.** Councilor Ruzicka asked for an update on the schedule for the annual financial audit. The Comptroller updated the Council and stated the process would begin in October.
- **G. Councilor Ruzicka** asked about the update of the Capital Plan. The Manager stated that the Director of Capital Development and Grants is working on the update and it would be brought before Council probably in August.
- **H.** Councilor Cuddy stated he would like to see a vision or mission statement process conducted for the city.
- I. **Executive Session.** Council voted to enter an executive session regarding matters pertaining to:

1. Update on collective bargaining negotiations. (NYS Public Officers Law, Article 7 §105.1.e. collective negotiations pursuant to article fourteen of the civil service law;)

Motion to enter an executive session was made by Councilor McCormick, seconded by Councilor Camardo. The motion carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye. Council entered into executive session at 8:17 p.m. Executive session adjourned at 9:14 p.m.

**Adjournment:** By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 9:15 p.m.
