The meeting of the Auburn City Council was called to order at 6:00PM in the City Council Chambers 24 South St. Auburn NY by Mayor Quill.

Roll Call – The City Clerk called the roll. Mayor Quill, and Councilors McCormick, Camardo, Cuddy and Ruzicka were all present.

Moment of Silent Prayer or Reflection – Mayor Quill asked for a moment of silent prayer.

Mr. Tunney spoke regarding the new Refuse Collection Fee that was on his recent property tax bill. He stated he owns a two-unit house and lives in one of the units, the other unit is vacant but will be filled by an individual soon. He suggested Council go back to the way it used to fund curbside refuse collection.

• Sheila Gallup 6 St. Anthony Street

City Manager's Report – The Manager reported on the following:

- The City Manager reported that the City will begin to enforce the city's code for the placement of temporary signs. During the week of July 28, City staff will be picking up and disposing of any signs—advertising, events, public service, non-profit, real estate and any others--that are located in the City's right of way (ROW). Residents and property owners are being asked to please remove any signs, or properly place them on private property per the City's sign regulations, prior to July 28, 2014. For any questions related to the City's sign regulations, please call the Office of Code Enforcement at 255-4110.
- The City has been informed that it has received some reimbursement funds from the State of New York Department of State Local Government Efficiency Grant Program. \$275,749.55 was received to reimburse costs associated with design and engineering on

- the Franklin Street Water Main Replacement project. \$47,465.84 was received to reimburse costs associated with previous work with the exploration of a Water and Sewer Regionalization effort.
- Effective immediately the City Clerk has been appointed (by the City manager) as the city's American's with Disabilities Act Title II compliance officer.
- The Civil Service Office will be relocating in City Hall from its basement location to an office on the second floor next to the City Manager's secretary's office.

Motion to amend the proposed Rules and Procedures by Councilor Camardo, seconded by Councilor McCormick. The motion to amend the proposed Rules and Procedures was to change the wording of Section I to the following:

I. REGULAR MEETINGS

Meetings of the Auburn City Council shall be held in the Council Chambers at Memorial City Hall, commencing at 6:00 PM the first four Thursdays of each month weekly in Council Chambers at Memorial City Hall, 24 South Street, Auburn, NY or elsewhere upon public notice five days in advance thereof by resolution approved by Council.

The motion to amend carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye.

The motion to approve carried 3-2. Councilors McCormick, Cuddy, and Mayor Quill voting aye. Councilor Camardo and Ruzicka voting no.

Other Business

A. **Councilor Camardo** asked when the Council would receive an update regarding improvements to the water filtration plant. The manager reported that Council would be updated within a few weeks.

- **B.** Councilor Cuddy stated he still is looking for the city council to work on a mission and vision statement for the city. He would also like to see an effort to update the city's comprehensive plan.
- **C.** Councilor Cuddy and Councilor McCormick discussed the possibility of implementing a residential permit parking program as an attempt to resolve the parking situation on Easterly Ave. reported to the Council by Easterly Ave. resident Mr. Emanual Ferrara. Councilor McCormick stated she had researched info on the program as it exists in the city of Ithaca, NY and forwarded that information to the City Manager.
- **D.** Councilor Cuddy asked when work would begin on South Street. He wanted to know when the city would be scheduling an information meeting with South Street residents, businesses, and property owners.
- **E.** Councilor Ruzicka asked the City Manager when the Council would start discussion on long term financial planning. The Manager reported that it would be a topic on the July 24, 2014 Council agenda.
- **F.** There was a discussion among Council regarding what the city's Comprehensive Plan is. Councilors expressed various opinions about their views of what the plan is and what it means to the city.

Adjournment: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 7:54 p.m.
