- **A.** Councilor McCormick stated that when she met with staff from the Cayuga Economic Development Agency (CEDA) earlier this week she reviewed some information on demographics that she thought would be good to share with the entire Council. She asked if the City Manager could have the staff from CEDA prepare to discuss the information at their upcoming presentation to the Council.
- **B.** Councilor Camardo asked if the Council could have an update at future Council Work Session meetings on the Co-Gen Facility and on the plan to address excavations in City roads.
- C. Councilor Ruzicka stated that he thought the Manager and Council should take a look at information compiled by the Auburn Municipal Power Agency on switching the wastewater treatment facility power over to NYSEG from the City's Co-Gen facility. He stated there will be a \$400,000.00 \$450,000.00 investment needed by the City to make the switch and he is requesting the City Manager and City Comptroller conduct a financial analysis of this project before the City makes a decision to proceed.

- **D.** Executive Session Councilor McCormick made a motion to enter Executive Session, seconded by Councilor Camardo. Council voted to enter an executive session regarding the following matters:
- 1. Update on collective bargaining negotiations. (NYS Public Officers Law, Article 7 §105.1.e. collective negotiations pursuant to article fourteen of the civil service law;)

The motion to enter executive session carried 4-0. Councilors McCormick, Camardo, Cuddy, and Ruzicka all voting aye. The Council entered Executive Session at 7:56 p.m. Executive session adjourned at 8:42 p.m.
