Minutes

The meeting of the Auburn City Council was called to order at 6:00PM in the City Council Chambers 24 South St. Auburn NY by Mayor Quill.

1. Roll Call – The Deputy City Clerk called the roll. Mayor Quill, and Councilors McCormick, Camardo, Cuddy, and Ruzicka were all present.

8. Reports of City Officials

- **A.** City Manager's Report The City Manager reported on the following:
 - Updated Council on the Meter Replacement Program as part of the energy conservation program with Wendell Consultants. 88% of the water meters have been installed. In Line Services is a subcontractor with Wendell and they will be demobilizing, but will return in mid-September to install the

MXU's on the remaining meters. To date there are 292 owners who have not responded despite numerous attempts and repeated requests to schedule a meter replacement. There is another 111 water services that have bad piping that may require some work prior to a meter installation. At this point with In-Line Services demobilizing they will be transferring the remaining meters and equipment to City forces.

- The City Manager reported to council on the Mill Street Hydro Project has been load tested and operated. The City is currently waiting NYSEG's final sign off on the installation and after they do that we will begin commercial production with that hydro facility.
- City Manager reported to council the Celebration of the rededication of the State Street Dam. The City has concluded a \$3.1 million project with substantial renovations to the dam, stabilizing it and made it safer for generations in the future. The City Manger wanted to compliment Christina Selvek for coordinating that and our Engineer for hosting a nice event
- The City Manger reported to council on the issue associated with the Co-Gen Facility. Back in April there was a penalty provision in the sales agreement with part of the negotiation required the City to pay a penalty which is \$317,000. That amount has not been paid to the previous owners and it is being held in an escrow account. This is a federal tax penalty because the transfer occurred prior to the expiration of 5 years under which the grant would have time out in terms of penalty. The City is actively working with Federal delegations and Christina Selvek has been coordinating telephone conferences. Every federal office or elected representative is involved and the City is seeking a waiver.

Councilor Cuddy wanted to comment on this evening resolution. Councilor Cuddy asked Corporation Counsel John Rossi if council could have a resolution to dissolve the agency. Corporation Counsel John Rossi explained as to why that could not happen.

Councilor Ruzicka wanted to complete the AMPA discussion. Councilor Ruczika also discussed the matter of the water department and firmly believes the City can work within its Charter and still have consolidation efforts.

Councilor Camardo asked the City Manager on the policy on the road construction and excavations in the street and following up on this and when the City Manager is going to bring it back to council. The City Manager stated that they will be bringing this back during a work session meeting within the next couple of weeks.

Executive Session – Councilor Camardo made a motion to enter Executive Session, seconded by Councilor Ruzicka. Council voted to enter an executive session regarding the following matters:

1. Update on collective bargaining negotiations. (NYS Public Officers Law, Article 7 §105.1.e. collective negotiations pursuant to article fourteen of the civil service law;)

The motion to enter executive session carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye. The Council entered Executive Session at 8:30p.m. Executive session adjourned at 8:54 p.m.

Adjournment: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 8:55 p.m.
