Minutes

The meeting of the Auburn City Council was called to order at 6:00PM in the City Council Chambers 24 South St. Auburn, NY by Mayor Quill.

1. Roll Call – The City Clerk called the roll. Mayor Quill, and Councilors McCormick, Camardo, Cuddy, and Ruzicka were all present.

The following City Staff was present:

- 2. Pledge of Allegiance to the Flag Mayor Quill led the Pledge of Allegiance.

3. Moment of Silent Prayer or Reflection – Mayor Quill asked for a moment of silent prayer.

Mayor Quill announced two items: 1. Resolution #176 of 2014 Authorizing the Amendment to the Sale of a Parcel of Land at 5 Frederick Street was being carried into the meeting for Council consideration, and 2. Appointment Resolution #173 of 2014 confirming appointments to the Auburn Industrial Development Authority was being pulled from the agenda. He asked for Council consent to add Resolution #176 of 2014 and no member of Council objected.

4. Public Announcements –

The Clerk read the following:

A. Wreaths Across America Day is December 13, 2014. Wreaths Across America is a nonprofit organization with the mission of continuing and expanding the annual wreath-laying ceremony at Arlington National Cemetery in our Nation's Capital. Locally there will be a Wreaths Across America Remembrance Ceremony held on December 13, 2014 at 12 p.m. (Noon). This ceremony will be held at the St. Peter & John Episcopal Church located across the street from Veteran's Memorial Park at 160 Genesee Street. This event is organized by the Cayuga County Vietnam Vetarns of America Chapter 704 with the assistance of students from the Dana L. West High School of Port Byron.

A. Motion to approve by Councilor Cuddy, seconded by Councilor Camardo.

The motion carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye.

D2. Appointment Resolution #173 of 2014 confirming appointments to the Auburn Industrial Development Authority. Mayor Quill announced that this resolution had been pulled from the agenda.

D3. Award Resolution #174 Awarding the Engineering and Design Portion of the North Hunter Brook Culvert Preservation Project

Motion to approve by Councilor Ruzicka, seconded by Councilor McCormick.

The motion carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye.

D4. Resolution #175 of 2014 Special Meeting for Mandatory Workplace Training for City Council

Motion to approve by Councilor Ruzicka, seconded by Councilor Camardo.

The motion carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye.

D5. Resolution #176 of 2014 Authorizing the Amendment to the Sale of a Parcel of Land at 5 Frederick Street

Motion to approve by Councilor McCormick, seconded by Councilor Camardo.

Mayor Quill stated that because this was a land Sale Resolution it would require 4 votes of the Council to carry.

Councilor Ruzicka made a motion to table the resolution, seconded by Councilor Camardo. The motion to table did not carry 2-3. Councilors Camardo and Ruzicka voted aye, Councilors McCormick, Cuddy, and Mayor Quill all voting no.

The motion to approve did not carry 3-2. Councilors McCormick, Cuddy, and Mayor Quill all voting aye. Councilors Camardo and Ruzicka voting no.

The City Clerk announced that the motion did not carry because it did not have the 4 aye votes required to carry.

10. Other Business

A. Councilor Camardo had the following items: 1. He discussed that he required more time and notification from City staff to be able to make a decision on the sale of 5 Frederick Street. 2. He asked the City Manager for a progress report on his earlier request for a budget calendar which would include discussion on consolidation and reorganization. The City Manager responded that he had been focusing on development of a five year financial plan for the City and that he would be bringing that before Council at the December 18, 2014 City Council meeting. 3. He mentioned that he had previously asked that a meeting be set up with the Cayuga Economic Development Agency to discuss Economic Development and he was wondering when that could be scheduled.

B. Councilor Ruzicka stated that he required more time and notification from City staff to be able to make a decision on the sale of 5 Frederick Street.

C. Councilor McCormick stated that the sale of 5 Frederick Street was the topic of Council discussion at an Executive Session the Council previously held pertaining to the sale of City owned land. She stated the Council had been briefed by staff at that meeting.

D. Councilor Ruzicka stated that information discussed during the meeting and questions brought up by other members of Council about the sale of 5 Frederick Street led to his decision that he needed more time to investigate the matter further and therefore he did not vote for the sale.

E. Mayor Quill brought up the matter of tipping fees for the City Landfill that was discussed at the November 25, 2014 Council meeting. He stated that he thought the Council should give the City Manager and appropriate staff the ability to negotiate high volume contracts at lower tipping rates with private haulers. He asked Council to think about this matter for future Council discussion at future Council meetings.

F. Councilor Ruzicka stated that he wanted the staff to provide the Council with the cost to the City of taking in a ton of municipal solid waste, as well as, all other categories brought in at the City Landfill. He stated he would need such information for making future decisions on the matter.

G. Executive Session – Councilor McCormick made a motion to enter Executive Session, seconded by Councilor Camardo. Council voted to enter an executive session regarding the following matters:

1. A matter pertaining to the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion,

discipline, suspension, dismissal or removal of a particular person or corporation; (NYS Public Officers Law, Article 7 §105.1)

The motion to enter executive session carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye. The Council entered Executive Session at 7:00 p.m. Executive session adjourned at 7:05 p.m.

Adjournment: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 7:06 p.m.
