- Economic Development by Andrew Fish, Executive Director of Cayuga Economic Development Agency. Mr. Fish presented to the Council on Governor Cuomo's new initiative that will allow 7 different regions in the State to compete for \$1.5 billion in economic development funds that will be awarded to 3 of the regions at \$500 million per region. The program was announced by the Governor earlier in the day in Rochester, NY. The applications for the proposals will be due by July 1, 2015. Mayor Quill and all members of Council discussed the topic. It was stated by Mayor Quill that the City should be called upon by Mr. Fish for whatever assistance is needed during the compilation of the application.
- Cayuga County Soil and Water Conservation District by Doug Kierst, Executive Director. Mr. Kierst provided an overview of the services provided by his department, especially as they pertain to the protection of Owasco Lake.

10. Other Business

- **A. Councilor McCormick** spoke to discuss the meeting agendas and minutes that are posted on the City website. She stated that the buttons are on the agenda page for the City Council, Planning Board, Zoning Board, and Historic Resources review Board meeting agendas. All agendas but the Zoning Board appear on the page. She asked when we could expect to see the Zoning Board agendas. She stated this is a very useful page for the public.
- **B. Councilor Camardo** spoke regarding a conversation he had with a member of the Auburn Municipal Power Agency Board (AMPA) and he asked if we could schedule AMPA to be on an upcoming Council agenda.

Executive Session – Councilor Ruzicka made a motion to enter Executive Session, seconded by Councilor McCormick. Council voted to enter an executive session regarding the following matters:

- 1. A matter pertaining to discussion of collective bargaining.
- 2. A matter of discussion that would be considered confidential under attorney client privilege regarding potential litigation against the City. (Section 4503 of the Civil Practice Law and Rules which establishes that a confidential communication between attorney and client shall be privileged. Pursuant to this section, Council will be receiving legal advice from its attorney which fulfills the requirement provided in Section 108(3) of the Public Officers Law allowing this exemption.)

The motion to enter executive session carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye. The Council entered Executive Session at 7:43 p.m. Executive session adjourned at 8:15 p.m.

Adjournment: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 8:16 p.m.
