8. Reports of City Officials

A. City Manager's Report

- The City has received notice that since the City obtained ownership of the Cogen facility within the 5 year recapture period the City is being requested by Auburn Energy LLC (former owners of the Cogen Facility) to release the escrowed funds in the amount of \$316,716.40 to them for the repayment to the US Department of Treasury. The City has been aware this payment would be coming and has had the money in savings. The City is currently working with Senator Gillibrand and Senator Schumer's office to ask the U.S. Department of Treasury to waive the penalty. If the penalty could be waived the money could go into the power utility fund to be used toward the City's energy project needs.
- The City has learned more information on the Clean Renewable Energy Bond (CREBS) financing that it was approved for. A preliminary estimate shows the City will save at least \$3 million in interest expense over a 20 year period on this reduced financing.

B. Reports from members of Council

• Mayor Quill reported that earlier in the day he attended a meeting regarding the N. Division Street Dam project and that the City staff in attendance really demonstrated to be well informed of the details of the project.

Councilor Camardo brought up having a similar discussion for the Dunn and McCarthy site on Washington Street and the Mayor asked that the manager work on this as well, but as a separate issue.
