1. FINANCIAL RESOLUTION #103 OF 2015. AUTHORIZING THE MAYOR TO ACCEPT A GRANT FROM THE NYS EMPIRE STATE DEVELOPMENT AGENCY FOR THE NORTH DIVISION STREET HYDRO FACILITY.

By Councilor Camardo, seconded by Councilor McCormick. September 17, 2015. WHEREAS, the City of Auburn is the owner and operator of the North Division Street hydroelectric facility located along the Owasco River; and

WHEREAS, improvements to this facility have been identified in the FY 2014-2018 City Capital Improvement Program plan and were previously authorized by City Council in Bond Ordinance #4 of 2015; and

WHEREAS, the City of Auburn submitted a request through the NYS Consolidated Funding Application (CFA) to the NYS Empire State Development agency for additional funding assistance towards smart grid and upgrades at the North Division Street hydro facility; and WHEREAS, as a result of this request, the City of Auburn has received an incentive proposal from the New York State Empire State Development (ESD) in the sum of \$1,200,000; and WHEREAS, the Mayor of the City of Auburn must be authorized to accept the grant funding and execute all necessary documents in connection therewith prior to commencing the project. NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, that the Mayor of the City of Auburn is hereby authorized and directed to execute an incentive proposal agreement and execute all necessary documents with the NYS Empire State Development for smart grid and hydro improvements at the North Division Street hydroelectric

facility, in the amount of \$1,200,000 and the revenue recognized in the North Division St. Hydro Upgrade capital account (# ED 99.359.HY).

The motion to approve Resolution #103 of 2015 carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka and Mayor Quill all voting aye.

2. AGREEMENT RESOLUTION #104 OF 2015. AUTHORIZING A REPLACEMENT AGREEMENT WITH NEW YORK STATE ELECTRIC & GAS (NYSEG) FOR THE NORTH DIVISION STREET DAM HYDRO FACILITY PROJECT.

By Councilor Cuddy, seconded by Councilor Ruzicka. September 17, 2015.

WHEREAS, on October 11, 1991 the City of Auburn entered into a Power Purchase Agreement ("PPA") with New York State Electric and Gas ("NYSEG") for the purchase of electricity from the City of Auburn's North Division Street hydro facility; and

WHEREAS, the PPA is for a thirty (30) year period commencing on the date of commercial operation, February 1992, with payments for the first twenty (20) years at a contractual base rate and for the second period (years 21-30) NYSEG will pay 90% of actual avoided costs; and WHEREAS, the City of Auburn now desires to terminate the PPA with NYSEG provided that the City enters into a replacement agreement for the Facility; and

WHEREAS, the Replacement Agreement will entail a cash payment of \$110,000 consisting of a \$10,000 deposit and the balance due when the upgraded N. Division Street Facility is placed into service; and

WHEREAS, under the Replacement Agreement the City will make payments to NYSEG in an amount equal to 5% of the net revenue earned by the upgraded facility through February 2, 2023; and

WHEREAS, the upgraded hydro facility will result in an increase in expected annual energy production due to the replacement of the existing 810 kw Flygt Turbine to a 1.1 MW Kaplan Turbine; and

WHEREAS, it is necessary to authorize the Mayor to enter into the Replacement Agreement with NYSEG prior to commencing site improvements at the North Division Street Dam Hydro Facility.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Auburn, New York, that it does hereby authorize the Mayor to enter into a replacement agreement with NYSEG of Binghamton, New York with a term beginning at the in service date on or before December 31, 2017 of the upgraded North Division Street Hydro Facility through February 2, 2023; and BE IT FURTHER RESOLVED, that the City Comptroller is authorized to make payment in the amount of \$10,000 deposit and the balance of \$100,000 within 10 days of the in service date from Power Utility Fund Hydroelectric Account (#E8240.450).

The motion to approve Resolution #104 of 2015 carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka and Mayor Quill all voting aye.

3. AGREEMENT RESOLUTION #105 OF 2015. AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT WITH C&S ENGINEERS, INC. FOR THE NORTH DIVISION STREET DAM HYDRO PROJECT.

By Councilor Ruzicka, seconded by Councilor McCormick. September 17, 2015. WHEREAS, the City of Auburn has been awarded a grant in the amount of \$1,200,000 from New York State Empire State Development to implement smart grid and facility improvements at the North Division Street Dam Hydroelectric Facility (the "Project"); and WHEREAS, these facility improvements include, but are not limited to, site preparation and construction of a new powerhouse building, removal and replacement of the turbine and generator systems, repairs and replacement of the power channel as well as the trash rake system; and

WHEREAS, the City of Auburn has issued a Request for Qualifications for professional engineering services related to the completion of the proposed scope of work for the North Division Street Dam hydroelectric facility; and

WHEREAS, on July 24, 2015 the City of Auburn received five (5) responses to the Request for Qualifications and through a competitive review process, C&S Engineers, Inc. of Syracuse, NY was selected with a proposed fee not to exceed \$329,520.00.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Auburn, New York, that it does hereby authorize the Mayor to enter into a professional services agreement with C&S Engineers, Inc. of Syracuse, New York at a cost not to exceed \$329,520.00 to be charged to a designated capital account entitled North Division Street Hydro Upgrade (#ED 8292 440 HY). The motion to approve Resolution #105 of 2015 carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka and Mayor Quill all voting aye.

F. Staff/Vendor Presentations

1. Presentation on SRO's and Crossing Guards. With the beginning of the school year Brian Neagle, Chief of Police made a presentation to the Council on the joint efforts of the City and School District to keep local schools safe. He reviewed the Crossing Guard program, as well as, the School Resource Officer program.

10. Other Business

A. Mayor Quill discussed an idea he would like the Council to consider in the future about setting up a process for individual Councilors to request information through the City Manager. He would like to develop a template that could be used by all Councilors. The Council discussed and asked that the issue be provided to the City Manager for his input.

- B. Executive Session. Councilor McCormick made a motion to enter Executive Session, seconded by Councilor Cuddy. Council voted to enter an executive session regarding the following matters:
- 1. Discussion on three matters pertaining to the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. (NYS "The Open Meeting Law", Article 7, Section 105-F)

The motion to enter executive session carried 5-0. Councilors McCormick, Camardo, Cuddy, Ruzicka, and Mayor Quill all voting aye. The Council entered Executive Session at 7:01 p.m. Executive session adjourned at 7:54 p.m.

Adjournment: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 7:55 p.m.
