Several people spoke to share their thoughts on the future use of the site. Public comments will be collected through September 30, 2015. Following the public comment period the staff will work towards taking the comments received and writing a request for proposals for the property.

- 1. Economic Update Presentation by Andrew Fish, Executive Director of the Cayuga Economic Development Agency (CEDA). Mr. Fish reviewed a series of statistics that are compiled to track the local economy and how it compares to the region and country. He reviewed economic progress that has been made in the past 2 years by his Cayuga Economic Development Agency. He also provided an overview of what the Central New York Regional Economic Development Council's plan will be as part of the State's Upstate Revitalization Initiative competition. The proposal for that competition is due in October and results are expected to be announced in December.
- **2.** Presentation on Utility Billing Enhancement by Vicky Murphy, Director of Municipal Utilities. Ms. Murphy provided an overview of work that has been done over the past year to install new residential water meters throughout the City. She also discussed new software the City is using to track water usage. This new system will provide a new billing system and water users will begin seeing a different look to their water bills after the new year.

A. Councilor Camardo stated that at a previous Council Meeting he had asked for a report on progress pertaining to capital projects that the Council has borrowed money for in recent years such as work at City Hall and the installation of a fence at the Department of Public Works. He asked if the Council could receive an update on these projects. He also asked how progress was coming on his request for information pertaining to billing people full water and sewer fees for the filling of pools. The City used to have a policy that it would credit people for sewer charges that used a high volume of water to fill their residential pool.

B. Mayor Quill stated that he has been asked to speak to a civic group the evening of October 22, 2015. He asked if the Council would be open to changing the meeting time to an earlier time to accommodate his being able to speak to this group about the City of Auburn. The Council discussed and it was decided that a resolution for an earlier meeting time could be prepared.
