- He noted that for various reasons the Auburn Police Department is down 3 full time officers and that overtime expenses will be impacted during this time that the officers are away.
- He discussed proposals received by the City as a result of the request for proposals that were issued seeking a company to operate the landfill gas to electric cogeneration facility. He stated that he is moving forward with the Civil Service Office attempting to create a job position of a maintenance person that would hopefully be able to conduct this work in the future. All members of Council spoke in favor of moving forward on the creation of such a position.
- He discussed increased installation of pedestrian walkway signage throughout the City.
- He discussed upgrades the City has recently made to the St. Frances Playground.

WHEREAS, it is recommended that the following persons be appointed to the Human Rights Commission for a term effective October 1, 2015 and expiring September 30, 2018, all of whom are residents of the City of Auburn:

D2. APPOINTMENT RESOLUTION # 107 OF 2015, APPOINTING MEMBERS OF THE CEMETERY COMMISSION

WHEREAS, Section 135 of the Auburn City Code entitled "CEMETERIES" provides for the establishment of a cemetery to include a place dedicated for the burial of the dead and the City owns and maintains Soule Cemetery in the Town of Sennett which is regulated by Chapter 135 of the City Code; and

WHEREAS, Section 135-12 entitled "Cemetery Commission, paragraph A" states that there shall be a commission consisting of eight individuals to be known as the Cemetery Commission which shall consist of the City Manager, Comptroller, Director of Public Works, a member of Council, and one cemetery lot owner residing in the City of Auburn, one cemetery lot owner residing in the Town of Sennett, one licensed Funeral Home Director regularly conducting a funeral business in the City of Auburn and one member-at-large; and

WHEREAS, the appointment of members of the Cemetery Commission are recommended by the Mayor and approved by Council and currently members of the Commission need to be appointed due to their terms expiring this year; and

WHEREAS, it is necessary that the Mayor recommend the following individuals to serve as members of the Cemetery Commission:

Debra McCormick, 30 South Marvine Avenue in the City of Auburn to serve as City Council representative;

William Jacobs, 95 Cottage Street in the City of Auburn to serve as the cemetery lot owner residing in the City of Auburn;

Elaine Harter, 6982 Chestnut Ridge Road in the Town of Sennett to serve as the cemetery lot owner residing in the Town of Sennett;

Steven Pelc, 40 Chase Street in the City of Auburn to serve as the licensed Funeral Home Director regularly conducting a funeral business in the City of Auburn;

NOW THEREFORE BE IT RESOLVED that upon the recommendation of the Mayor the Auburn City Council confirms the following appointments to the Cemetery Commission:

BE IT FURTHER RESOLVED that all appointees listed shall serve for a term effective October 1, 2015 through September 30, 2017; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately upon its adoption.
