WHEREAS, The City of Auburn is an Entitlement Community for the Community Development Block Grant (CDBG) Program and is required to submit a Five Year Consolidated Plan with an annual statement of objectives and uses of the CDBG Entitlement Program funds; and

WHEREAS, the City of Auburn has prepared the 2015-2019 Consolidated Plan and the related 2015-2016 Annual Action Plan outlining the community development activities, objectives and budget for use of funds; and

WHEREAS, The City of Auburn has held public meetings to solicit participation and input into the preparation of both the proposed Consolidated Plan and Annual Action Plan; and

WHEREAS, The City of Auburn Planning Board held a Public Hearing in Council Chambers on November 5, 2014 and the City Council of the City of Auburn, New York held a Public Hearing on February 12, 2015 during the Public Comment period; and

WHEREAS, The City of Auburn published the Notice of the Consolidated Plan and Action Plan on January 2, 2015 to start the local comment period; NOW

THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn, New York:

1. The City Council does hereby approve the 2015-2019 Consolidated Plan and 2015-2016 Annual Action Plan; and
2. The City Council does hereby authorize the Mayor to sign the Application for Federal Assistance and submit the 2015-2019 Consolidated Plan and 2015-2016 Annual

Action Plan to the U.S. Department of Housing and Urban Development for the CDBG entitlement grant to complete the objectives of the 2015-2016 Annual Action Plan; and

The City Council does hereby authorize and direct the Mayor to sign the Funding Approval / Agreement with the U.S. Department of Housing and Urban Development necessary to further the objectives of the 2015-2016 Annual Action Plan and all related Subrecipient and other agreements necessary to further the objectives of the Annual Action Plan; and
4. The City Council does hereby authorize the City Comptroller's Office to recognize grant revenue and appropriate funding into the correct departmental budget.
