

**AWARD RESOLUTION #89 OF 2015**

**AWARDING THE CONTRACT FOR THE 2015 ROAD  
IMPROVEMENT PROGRAM**

**WHEREAS**, on May 7, 2015, the Auburn City Council authorized Bond Resolution #3 of 2015 in the amount of \$ 2,000,000 of which \$ 1,525,000 was authorized to fund the 2015 Road Improvement Program; and

**WHEREAS**, the 2015 Road Program involves street to be improved by asphalt resurfacing, including partial reconstruction, patching, crack sealing, milling the road surfaces, and installing asphalt trueing and leveling and top courses; and

**WHEREAS**, on June 23, 2015, bids were opened for the 2015 Road Program. The following bids were received:

**WHEREAS**, it is necessary that the Auburn City Council awards the 2015 Road Program contract to F. Rizzo Construction, Inc. for their low bid of \$ 1,245,950.

**NOW THEREFORE BE IT RESOLVED** that the Auburn City Council does hereby award the 2015 Road Program contract to the low bidder, F. Rizzo Construction, Inc. for their bid of \$ 1,245,950; and

**BE IT FURTHER RESOLVED** that the cost of the Resolution is \$ 1,245,950.00, of which \$ 1,134,193.53 is to be charged to 2015 Road Program Acct. #HA5110-440-HV, \$ 30,000.00 is to be charged to Revolving Loan Sidewalk Acct. #HA5497-440-001, \$ 6,747.22 is to be charged to 2010 City

City of Auburn, New York

Sidewalk Acct. #HA5497-440-FT, and \$ 75,009.25 is to be charged to 2011 City Sidewalk Acct. #HA5497-440-GH.
