AWARDING A BID FOR THE 2015 COMMUNITY DEVELOPMENT BLOCK GRANT SIDEWALK REPLACEMENT PROGRAM

WHEREAS, the Community Development Block Grant Sidewalk Replacement Program provides for new sidewalks and/or curbing installation in targeted areas of the City which are so designated; and

WHEREAS, the proposed areas for the year's construction are: Dunning Ave. - from Clymer St. to Genesee St., Arlington Ave. - from Englewood Ave. to Genesee St., Kensington Ave. - from Englewood Ave. - from Arlington to Kensington; and

WHEREAS, as part of this year's program, the City will also review the condition of existing street trees that are adjacent to the sidewalks slated for replacement and trees that are found to be diseased, in decline and/or dead will be removed and replaced; and

WHEREAS, bids for the 2015 CDBG Sidewalk Replacement Program were opened on July 14, 2015, and the following bids were received:

WHEREAS, it is necessary that the Auburn City Council award the fiscal year 2015/2016 CDBG Sidewalk Replacement Program contract to the lowest qualified bidder which is Diamond Excavating in the amount of \$201,865 contingent upon the City receiving an executed fiscal year 2015/2016 contract from the US Department of Housing and Urban Development.

NOW THEREFORE BE IT RESOLVED that the Auburn City Council does hereby award the 2015 Community Development Block Grant Sidewalk Replacement Program contract to Diamond Excavating which is the lowest qualified bidder which has
