William Jacobs, Cottage Street

Mr. Jacobs is a former member of the City Council, he spoke regarding the stop light at the corner of State Street and Cottage Street. He suggested the light be turned to a 4 way stop because the two way stop that it is currently set at creates difficulty for drivers. He also discussed the City requiring brown paper bags for leaf pick-up and stated he has observed such bags ripping when they are soaked in the rain, he suggests that City crews have rakes and shovels on the trucks so that they can clean the City streets if the bags break when being picked up. He also wished City Manager Selby a happy retirement and thanked him for his service to the City.

Laurel Auchampaugh, Martin Road, Town of Owasco

Ms. Auchampaugh spoke regarding the Auburn Schine Theater and she encouraged the City to take a look at conditions of the building.

D1. FINANCIAL RESOLUTION #42 OF 2016

AMENDING THE CITY OF AUBURN FEE SCHEDULE

WHEREAS, the City of Auburn annually adopts a Fee Schedule at the same time that the main budget for the upcoming fiscal year is adopted; and

WHEREAS, the City has been approving an increasing number of special events that are being held on City streets and rights-of-way which require the closure of these public spaces to normal traffic and parking, and, in addition, the City Manager has instituted a permitting system in order to provide a consistent and uniform process for reviewing and approving the permit applications; and

WHEREAS, the permitting process involves staff time in the City Manager's Office, Department of Public Works, Auburn Fire Department and Auburn Police Department reviewing the applications and working with the applicants on the logistics of the events and specifying special conditions that assure that events are conducted in a safe and orderly manner and are in compliance with State Liquor Laws, City Codes and other various other State laws; and

WHEREAS, these events have a positive impact in helping revitalize downtown and are enjoyed by both residents and visitors but consume staff resources, affect parking revenues and restrict access to public rights-of-way; and

WHEREAS, these event applications and other fees need to be revised and updated in order to attempt to offset the cost of staff time to process and approve permits and cover staff costs associated with street closure and cleanup activities; and

WHEREAS, attached hereto and made a part hereof are a list of revised fees to amend and add to the City of Auburn Fee Schedule and it is necessary that the Auburn City Council approve the same.

NOW THEREFORE BE IT RESOLVED that the Auburn City Council does hereby approve the amendment and approval of increased fees attached hereto to be added to the City of Auburn Fee Schedule.

D2. COUNCIL RESOLUTION #43 OF 2016

AUTHORIZING SETTLEMENT OF THE REAL PROPERTY TAX ASSESSMENT PROCEEDING, AUBURN ASSOCIATES, LLC v. CITY OF AUBURN ET Al., CONCERNING THE REAL PROPERTY LOCATED AT 191 GRANT AVENUE

WHEREAS, on June 23, 2014, and June 15, 2015, Auburn Associates, LLC ("Auburn Associates") commenced proceedings challenging the real property tax assessments on the property it owns located at 191 Grant Avenue, Auburn, New York (the "Property"); and

WHEREAS, the Property is currently assessed for \$228,500, and Auburn Associates has claimed a reduction of this assessment to \$75,000; and

WHEREAS, a review of the income method of valuation of the Property shows an estimated current fair market value of the Property to be \$100,000, and a review of the sales comparison method of valuation shows an estimated fair market value of the Property to be \$150,000; and

WHEREAS, New York Real Property Tax Law, Section 302(1), requires that all property be valued according to its existing condition, not its potential use; and

WHEREAS, the attorneys at Bond, Schoneck & King, PLLC ("BSK") have appeared and intervened on behalf of the City of Auburn and Cayuga County in these proceedings; and

WHEREAS, the attorneys at BSK have reviewed and analyzed the Property valuation with the City of Auburn and Cayuga County; and

WHEREAS, the Parties to these proceedings have agreed that a reduction of the Property's assessment to a value of \$125,000 would be in the best interests of all parties and would avoid further litigation expense; and

WHEREAS, the Cayuga County Legislature must also approve the settlement as proposed;

NOW THEREFORE BE IT RESOLVED that the Auburn City Council does hereby authorize the attorneys at Bond, Schoneck, & King, PLLC, to accept a settlement agreement with Auburn Associates, LLC, wherein (1) the tax assessment for the real property located at 191 Grant Avenue, Auburn, New York, shall be reduced to \$125,000; and (2) refunds shall be paid to Auburn Associates, LLC, for the 2014/2015, and 2015/2016 tax years from the Judgments and Settlement Account No. A1930.453 in an amount not to exceed \$3,000.
