6. Public to be Heard – Mayor Quill opened the Public to be Heard portion of the Council meeting and the Clerk read the Public to be Heard rules.

Chris Major, representing Police Union

(Mr. Major submitted his remarks to be included in the minutes.) I'm here tonight to reaffirm our desire to have the Auburn Police Department Emergency Response Team reinstated. Since May of 2015 when Chief Neagle disbanded our ERT, we've steadily maintained our position that the money in our drug asset forfeiture accounts COULD in fact be used to replace some of our safety equipment that had reached it's expiration date. We thoroughly researched whether or not the purchase of this equipment would be permissible under federal guidelines. We interviewed agencies from surrounding areas, studied DOJ guideline manuals, and spoke to DOJ representatives. As a result of our research, we learned that not only would the purchase of this equipment be permissible, it was the exact type of purchase that asset forfeiture accounts were created for. Despite these findings and the presentation of these FACTS to everyone involved, all of our requests to use a small portion of these funds for this safety equipment were denied. Over the course of almost a year we unsuccessfully argued our point regarding the usage of these funds. In February of 2016, a DOJ representative actually came to Auburn from Washington DC and explained that the asset forfeiture money COULD be used to replace the expired ERT equipment. Although we do have an appreciation for the investigative process, we feel that our Department members and city residents have gone an unnecessarily long period of time without a local ERT. With recent news of an agreement from the DOJ to release a portion of the now frozen asset forfeiture accounts to make the ERT equipment purchase, we are excited that the team may be re-established soon. We were always confident in the fact that the seizure money could be used for these purchases, we just wish that somebody would have taken us more seriously sooner. We'd like to thank our members of Local 195 for having faith in us and allowing us to pursue what we knew was right all along. With the undeniable clarity that The Department of Justice has provided, we are hopefully optimistic that our Emergency Response Team can be re-assembled and put back into service as soon as possible. We have always felt strongly that we owe it to the citizens of our city to have an ERT ready to respond in the case of unforeseen emergencies. Thank you.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY COUNCIL OF THE CITY OF AUBURN, NEW YORK AS FOLLOWS:

- 1. The Project constitutes a "Type II Action" under 6 NYCRR § 617.5(c) (2) and no further action under the SEQR Act and the Regulations is required.
 - 2. This Resolution shall take effect immediately.

BOND ORDINANCE #3 OF 2016

BOND ORDINANCE OF THE CITY OF AUBURN, NEW YORK, AUTHORIZING THE ISSUANCE OF \$1,045,000 SERIAL BONDS TO FINANCE THE COST OF THE RECONSTRUCTION OF THE CITY WATER DISTRIBUTION SYSTEM

BE IT ORDAINED by Council of the City of Auburn, New York as follows:

- <u>Section 1</u>. The City of Auburn, New York (the "City") is hereby authorized to undertake the reconstruction of the City's water distribution system, including the reconstruction and improvement of the existing water distribution main on NYS Route 34, and the acquisition of replacement furnishings, equipment, machinery or apparatus required for the purposes for which such water distribution system are to be used at an estimated maximum cost of \$1,045,000 and to issue an aggregate \$1,045,000 in serial bonds pursuant to the provisions of the Local Finance Law to finance the estimated costs of the aforesaid object or purpose.
- <u>Section 2</u>. It is hereby determined that the maximum estimated cost of the aforesaid specific object or purpose is \$1,045,000, said amount is hereby appropriated therefor and the plan for the financing thereof shall consist of the issuance of \$1,045,000 in serial bonds (the "Bonds") of the City authorized to be issued pursuant to this Ordinance.
- <u>Section 3</u>. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty (40) years pursuant to paragraph 1 of Section 11.00(a) of the Local Finance Law.
- <u>Section 4</u>. Pursuant to Section 107.00(d)(3)(a) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.
- <u>Section 5</u>. The temporary use of available funds of the City, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this Ordinance.
- Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the City, payable as to both principal and interest by a general tax upon all the real property within the City without legal or constitutional limitation as to rate or amount, subject to certain statutory limitations imposed by Chapter 97 of the Laws of 2011 of the State of New York. The faith and credit of the City are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the City by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.
- Section 7. Subject to the provisions of this Ordinance and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for

level or substantially level or declining annual debt service, is hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.

- Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this Ordinance shall be from the City's Water Fund. It is intended that the City shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this Ordinance and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This Ordinance is intended to constitute the declaration of the City's "official intent" to reimburse the expenditures authorized by this Ordinance with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Regulation Section 1.150-2. Other than as specified in this Ordinance, no moneys are reasonably expected to be, received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.
- Section 9. The serial bonds and bond anticipation notes authorized to be issued by this Ordinance are hereby authorized to be consolidated, at the option of the City's Comptroller, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other Bond Ordinances previously or hereafter adopted by the City Council for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such ordinances. All matters regarding the sale of the bonds, including the date of the bonds, the consolidation of the serial bonds and the bond anticipation notes with other issues of the City and the serial maturities of the bonds are hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.
- Section 10. The City Comptroller, as Chief Fiscal Officer of the City, is further authorized to sell all or a portion of the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, to the New York State Environmental Facilities Corporation (the "EFC") in the form prescribed in one or more loan and/or grant agreements (the "Agreements") between the City and the EFC; to execute and deliver on behalf of the City one or more Agreements, project financing agreements, and letters of intent with the EFC and to accept the definitive terms of one or more Agreements from EFC by executing and delivering one or more terms certificates; and to execute such other documents, and take such other actions, as are necessary or appropriate to obtain a loan or loans from the EFC for all or a portion of the costs of the expenditures authorized by this Ordinance, and perform the City's obligations under its Bonds or bond anticipation notes delivered to the EFC, the project financing agreements and the Agreements.
- <u>Section 11</u>. The validity of the Bonds authorized by this Ordinance and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:
 - (a) such obligations are authorized for an object or purpose for which the City is not authorized to expend money; or
 - (b) the provisions of law which should be complied with at the date of the publication of this Ordinance or a summary hereof are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

- (c) such obligations are authorized in violation of the provisions of the Constitution.
- <u>Section 12</u>. The City Comptroller, as Chief Fiscal Officer of the City, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the City to provide secondary market disclosure as required by United States Securities and Exchange Commission Rule 15c2-12.
- <u>Section 13</u>. This Ordinance, or a summary of this Ordinance, shall be published in the official newspapers of the City for such purpose, together with a notice of the Clerk of the City in substantially the form provided in Section 81.00 of the Local Finance Law.
 - <u>Section 14</u>. This Ordinance is not subject to a mandatory or permissive referendum.
- <u>Section 15</u>. The Council hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Ordinance.

Section 16. This Ordinance shall take effect immediately upon its adoption.

D1. COUNCIL RESOLUTION #47 of 2016 ENCOURAGING THE FEDERAL OFFICE OF NATIONAL DRUG CONTROL POLICY TO HOLD A COMMUNITY FORUM

WHEREAS the federal government has ongoing efforts to treat and prevent opioid and heroin use in the United States and these efforts are administered by the Office of National Drug Control Policy; and,

WHEREAS the opioid and heroin epidemic is one of Central New York's most serious health problems and has impacted the lives of thousands of families throughout the entire region; and,

WHEREAS our federal representatives in the United States House of Representatives and Senate have urged the Office of National Drug Control Policy to hold a community forum on the opioid and heroin epidemic in central New York; and,

WHEREAS locally the epidemic has impacted hundreds of individuals in Auburn and Cayuga County through personal addiction to the drugs and has tragically ended the lives of dozens of individuals; and,

WHEREAS in Auburn and Cayuga County families and friends of those inflicted have organized the Heroin Epidemic Action League which has as its mission to create a community wide effort to prevent substance abuse and to initiate and implement needed resources to assist those affected by the disease of addiction; and,

WHEREAS it is imperative that all levels of our government and local community resources continue to work together to advance legislation, create awareness, enhance treatment options and provide adequate funding to curb this opioid and heroin abuse epidemic.

NOW THEREFORE BE IT RESOLVED that in light of the tragic circumstances associated with the opioid and heroin epidemic, the City Council of the City of Auburn, New York urges the Office of National Drug Control Policy to host a community forum in central New York to address the growing need for treatment and prevention opportunities for this epidemic; and,

BE IT FURTHER RESOLVED that the City Clerk is directed to send certified copies of this resolution to the President of the United States, the Director of the Office of National Drug Control Policy and all of the City of Auburn's federal representatives.

D2. LAND SALE RESOLUTION #48 OF 2016 AUTHORIZING THE SALE OF PROPERTY AT LAFAYETTE PLACE

WHEREAS, the City of Auburn owns a certain parcel of land situated on Lafayette Place and is designated as tax map parcel 115.65-1-50.1; and

WHEREAS, said parcel is adjacent to a resident's home owned by Tammy Tortorello, 58 Lafayette Place, Auburn, NY and she has maintained a portion of the City's parcel and is desirous of obtaining title in order to construct a garage and have her parcel of land become more regular than its current configuration; and

WHEREAS, the parcel of land which she is desirous of obtaining is approximately 60 feet in width and 216 feet in depth and she has had a surveyor delineate the property lines and the parcel that the City would convey to her is designated as parcel A on a map prepared by Anderson Surveys; and

WHEREAS, the City has no use for the parcel and a great deal of it is covered by vegetation and an abutment from an old railroad track and is surplus property not needed by the City of Auburn; and

WHEREAS, it is necessary that the Auburn City Council approve a sale of this parcel to the adjoining land owner for the sum of \$200.00 plus the cost of the recording of a deed from the City to Tammy Tortorello.

NOW THEREFORE BE IT RESOLVED that the City of Auburn does hereby authorize the sale of and conveyance of title to a parcel of land being a part of City owned property tax map #115.65-1-49.5 to Tammy Tortorello at 58 Lafayette Place, Auburn, New York in the sum of \$200.00 and the costs of recording the same and that said parcel is surplus property no longer needed by the City of Auburn.

- **WHEREAS,** the NYS DOT has requested that the City of Auburn enter into a Master Agreement for Right-of-Way Incidentals which is necessary to advance the North Division Street Bridge Replacement Project; and,
- **WHEREAS,** as part of the property agreement, the NYS DOT will acquire the necessary property ROW for this project and is requesting that the City of Auburn agrees to accept by Official Order the real property acquired for this project; and
- **WHEREAS,** the City of Auburn has received the master agreement and Schedule A from NYS DOT for the ROW Incidental Phase with a proposed non-Federal share cost of \$1,640 and a total cost of \$8,200; and
- **WHEREAS,** NYS DOT is requesting an advance of the ROW Acquisition Phase costs with a proposed non-Federal share of \$7,020 and a total Phase cost of \$35,100; and
