COUNCIL RESOLUTION #105 OF 2016, AUTHORIZING A 2016 CONSOLIDATED FUNDING APPLICATION (CFA) FOR A LOCAL WATERFRONT REVITALIZATION PROGRAM PROJECT TO PLAN AND DESIGN THE RIVERSIDE REGIONAL PUBLIC MARKET, DOWNTOWN VISITOR WELCOMING CENTER, AND MICROBREWERY.

**WHEREAS,** the City of Auburn prepared and submitted a Downtown Revitalization Initiative (DRI) application to New York State on May 31, 2016; and

**WHEREAS,** the City included a Riverside Regional Public Market, Downtown Visitor Welcoming Center, and Microbrewery in the DRI application, all of which are transformative projects that will attract and retain residents, visitors and businesses; and

**WHEREAS,** the City of Auburn desires to pursue alternative funding sources to move these projects forward; and

**WHEREAS**, the 2016 New York State Consolidated Funding Application (CFA) has released a request for proposals for Local Waterfront Revitalization Program projects for which municipalities are eligible to apply; and

**WHEREAS**, the City of Auburn's local waterfront revitalization project aligns with the Central New York Regional Economic Development Council's *Five-Year Strategic Plan: 2012-2016* priority goals of Revitalizing Urban Cores, Main Streets, and Neighborhoods; and

**WHEREAS,** the planning, design and construction documents for the Riverside Regional Public Market, Downtown Visitor Welcoming Center and Microbrewery have an anticipated cost of \$579,500; and

**WHEREAS,** the City of Auburn is requesting \$289,750 in funding assistance from the NYS Environmental Protection Fund Local Waterfront Revitalization Program, and will make available the required local match of 50%, or \$289,750, from the City General Fund; and

**WHEREAS,** the City of Auburn does not currently have the funding to pay for 100% of the planning and design for the Riverside Regional Public Market, Downtown Visitor Welcoming Center, and Microbrewery, and it is necessary to obtain New York State funding assistance for the project development and implementation.

**NOW THEREFORE BE IT RESOLVED,** by the City Council of the City of Auburn, New York:

- 1. That the Mayor, or appointed designee, is authorized to submit an application for funding under the 2016 CFA to implement a Local Waterfront Revitalization Program project in an amount estimated at \$579,500 in total project costs; and
- 2. That the City of Auburn is requesting \$289,750 in funding assistance from the NYS Environmental Protection Fund Local Waterfront Revitalization Program, and would make available the required local match of 50%, or equal to \$289,750, from the City General Fund; and
- 3. That the representative is also authorized, if awarded, to execute the grant assistance contract, submit project documentation, and otherwise act for the Municipality's governing body in all matters related to the project and state assistance; and

- 4. That the City Comptroller is authorized to recognize grant revenue, if awarded, and to appropriate the funds into the designated departmental or capital account(s).
- 5. That this resolution shall take effect immediately upon its adoption.
