A loading zone in front of 10-14 Genesee Street created by the removal of two metered parking spaces and the designation of a single 20 minute loading zone.

A 20 minute loading zone on the southernmost parking space on the west side of Seminary Avenue.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the designation made by the Auburn City Manager for two additional loading zones as follows:

A loading zone on the East side of State Street in front of premises designated as #2 State Street with hours as follows:

Monday through Friday 8:30 a.m. to 9:30 a.m. Monday through Friday 2:30 p.m. to 3:30 p.m.

A loading zone in front of 10-14 Genesee Street created by the removal of two metered parking spaces and the designation of a single 20 minute loading zone

D5. AWARD RESOLUTION #135 OF 2016. AWARDING A BID FOR A NEW BULLDOZER AT THE LANDFILL.

WHEREAS, on July 21, 2016, Council Resolution #99 authorized the Department of Public Works to advertise for bids for a new bulldozer to be placed in service at the landfill; and

WHEREAS, specifications were developed for the purchase of the equipment based upon the City's landfill experience and features desired for equipment used in landfill operations; and

WHEREAS, bids were received and opened on Friday, August 26, 2016, at Memorial City Hall; and

WHEREAS, two bids were received as follows:

WHEREAS, upon examination of the bid submitted by Five Star Equipment, it was discovered that the John Deere bulldozer, as submitted in the Five Star Equipment bid, did not meet 28 of the established specifications and as a result, the bid must be rejected; and

WHEREAS, the next bidder was Milton Caterpillar in the total amount of \$372,969 less salvage for a total net price of \$302,969 and the equipment submitted for the bid, namely, a Caterpillar Compactor was determined to be of superior design and the services associated with owning a Caterpillar bulldozer exceeded the services offered by the John Deere equipment; and

WHEREAS, it is necessary that the award of the bid for the Caterpillar bulldozer must be made to the next responsible bidder, Milton Caterpillar, set forth in the amount specified above and the cost of the equipment will be charged to Refuse Disposal – Other Equipment #AL8162.250 to be funded through the Solid Waste Fund Balance.

NOW THEREFORE BE IT RESOLVED that upon examination of the bids by the Department of Public Works, the Auburn City Council does hereby reject the bid from Five Star Equipment due to failure of the equipment to meet the established specifications of the bid; and

BE IT FURTHER RESOLVED that the Auburn City Council does hereby award a bid for a purchase of a new bulldozer to Milton Caterpillar, the lowest responsible bidder in the total amount of \$372,969 less a salvage value for the existing bulldozer in the amount of \$70,000 for a net total price of \$302,969; and

BE IT FURTHER RESOLVED that the cost of the bulldozer will be charged to Refuse Disposal – Other Equipment #AL8162.250 to be funded through the Solid Waste Fund Balance.
