COUNCIL RESOLUTION #165 OF 2016

OPPOSING THE FINGER LAKES RAILWAY PLAN TO TRANSFER SENECA MEADOWS LANDFILL LEACHATE IN THE CITY OF AUBURN

WHEREAS the City of Auburn was notified that the Finger Lakes Railway plans to transload leachate that is created at the Seneca Meadows landfill in Seneca County, New York at their rail spur located on Frank Smith Street in Auburn, New York so that the leachate may be shipped by rail to an industrial wastewater treatment facility in the State of New Jersey; and

WHEREAS trucking the leachate from their facility in Seneca County to the transfer facility located off of Frank Smith Street in Auburn requires that the Seneca Meadows Landfill, through their use of a transportation company, drive 6-9 eighteen-wheeler trucks through residential areas of the City of Auburn each day; and

WHEREAS Chapter 254 of the Code of the City of Auburn, titled "Solid Waste" requires that the operations involving the transport of solid waste material within the City of Auburn be licensed; and

WHEREAS, pursuant to the Auburn City Code, the Seneca Meadows Landfill and their contracted transportation company, are required to submit for the City of Auburn's consideration and ultimate approval an application for a license prior to commencing the proposed operations at the transfer facility; and,

WHEREAS representatives of the City of Auburn have contacted the New York State Department of Environmental Conservation to request that the department requires that a DEC permit be issued for this transload operation and that the permit process contain an opportunity for public comment.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, New York takes the following actions:

- 1. The City hereby notifies the Finger Lakes Railway that it opposes the use of their transfer facility located on Frank Smith Street in Auburn to be used for the transfer of Seneca Meadows Landfill leachate; and,
- 2. The Seneca Meadows Landfill is hereby notified that, pursuant to Chapter 254 of the Code of the City of Auburn, it is required to license its transportation company with the City of Auburn for the transporting and transfer of leachate at a Finger Lakes Railway transfer facility; and,
- 3. The New York State Department of Environmental Conservation is requested to conduct a permitting process that would include a public comment process to permit the proposed transfer of Seneca Meadows leachate in the City of Auburn; and,

4. The City Manager and City Clerk are directed to take necessary action to communicate the contents of this resolution to all respective parties.

Councilor Cuddy announced that there would be a public meeting of a citizen's group named Save Owasco Now on Monday, November 14, 2016 from 6pm-8pm at the Cayuga Onondaga BOCES campus to discuss matters pertaining to the quality of water of Owasco lake.

Councilor Carabajal brought up the topic of a Council goal setting session and the Council discussed.

Mayor Quill provided the following statement to the members of Council:

As part of the Governor's Tourism Summit, he announced unprecedented funding for new Regional Welcome Centers across the state and the City of Auburn has been fortunate enough to be chosen as one of the sites. Providing a location is the first step to making this Visitor's Center a reality. I am recommending to the City Council that the parking lot located at 25 South Street,

across the street from Memorial City Hall and the municipal parking garage, be considered as the site for the proposed Central NY Visitor's Center. While evaluating all the possible options in our Downtown, I believe this site will be most conducive to the project for its central location in our downtown, on a main thoroughfare NYS Rt 34 and its proximity to our underutilized municipal parking garage. I will ask the City Manager to prepare a resolution for the Council meeting of November 17th that will authorize the site to be used for this project.

Executive Session. Councilor McCormick made a motion to enter Executive Session, seconded by Councilor Carabajal. Council voted to enter an executive session regarding the following matters:

1. Discussion on one matter pertaining to the sale, lease or acquisition of real property. (NYS "The Open Meeting Law", Article 7, Section 105-h)

The motion to enter executive session carried 5-0. Councilors McCormick, Giannettino, Cuddy, Carabajal and Mayor Quill all voting aye. The Council entered Executive Session at 7:43 p.m. Executive session adjourned at 8:13 p.m.
