Those persons must file an Oath of Office with the City Clerk and with the County Clerk;

NOW, THEREFORE, BE IT RESOLVED, that the Auburn City Council does hereby appoint the list of persons attached to this Resolution as a Commissioner of Deeds pursuant to the authority provided by Section 139 of the Executive Law of the State of New York and said appointment shall be effective from the date of approval of this Resolution and shall continue until December 31, 2018.

COUNCIL RESOLUTION #170 OF 2016

TRANSFERRING OWNERSHIP OF THE MINOR LEAGUE FRANCHISE OWNED BY THE CITY OF AUBURN TO AUBURN COMMUNITY BASEBALL, LLC

WHEREAS, the City of Auburn (hereinafter referred to as "City") acquired a New York-Pennsylvania Professional League, Inc. (hereinafter referred to as "NY-Penn League") in 1982 and has owned the franchise since that date; and

WHEREAS, the City, in past years, has contracted with the Auburn Community Non-Profit Baseball Association, Inc. (hereinafter referred to as "ACB") to operate the franchise pursuant to three-year contracts, and for many years, the franchise had been profitable and funds were paid from ACB to the City from profits that were realized; and

WHEREAS, in recent years, the franchise has experienced losses which resulted in deficits and the City has advanced funds to pay vendors and unpaid fees; and

WHEREAS, it is necessary that the City divest itself from being the owner of the franchise and transfer the existing franchise to a business entity, which will facilitate operating the franchise in a profitable manner and avoid future losses and deficits; and

WHEREAS, the City has formed a limited liability company known as "Auburn Community Baseball, LLC," pursuant to New York State law, wherein the City is the sole owner and the operation of the Company will be run through various individuals known as "Managers," whose mission is to operate the franchise in a more business-like manner in order to maintain the franchise in a profitable situation, and to avoid deficits whereby City General Fund monies will no longer be necessary to pay for losses; and

WHEREAS, an agreement between the City and the Limited Liability Company to acquire the franchise shall be subject to approval by the NY-Penn League; and

WHEREAS, suitable consideration for the transfer of the franchise from the City to the Limited Liability Company will be the subject of an agreement, whereby the Limited Liability Company shall be responsible to the City for revenues received; and

WHEREAS, it is necessary that the Auburn City Council approves the transfer subject to the approval of the NY-Penn League.

NOW, THEREFORE, BE IT RESOLVED, that the Auburn City Council does approve the transfer of the minor league baseball franchise, which is a member of the New York-Pennsylvania Professional League, Inc. to Auburn Community Baseball, LLC, subject to approval by the New York-Pennsylvania Professional League, Inc.

WHEREAS, to begin the process of establishing the new Welcome Center in Auburn, Mayor Quill has proposed the use of a .97 acre site, which is City-owned property located at 25 South Street, existing tax parcel (ID# 116.53-1-36), the former location of the Auburn Women's Educational & Industrial Union (WEIU) building and the current location of a municipal parking lot.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, New York authorizes that a .97 acre site, which is City-owned property, located at 25 South Street, existing tax parcel (ID# 116.53-1-36), be designated to be used as the site of the new State of New York regional Welcome Center for the Central New York Region that will feature Taste NY Products and promote I Love New York attractions; and

BE IT FURTHER RESOLVED that the City Manager is authorized to utilize City staff to assist with the future planning and implementation of the new Regional Welcome Center.
