ORDINANCE # 13 OF 2016

AMENDING THE ZONING MAP OF THE CITY OF AUBURN, NEW YORK

By Councilor McCormick

December 1, 2016

WHEREAS, Chapter 305 of the Auburn Code, entitled Zoning, has been adopted by the Auburn City Council; and

WHEREAS, Article XIII, entitled Zoning Map, §305-94, entitled Purpose, states that this article was intended to establish zoning districts created by this chapter on a map of the City of Auburn to be known as the "Zoning Map of the City of Auburn"; and

WHEREAS, the zoning districts are established pursuant to §305, and districts are defined and enumerated; and

WHEREAS, the City of Auburn owns a parcel of real property situated at 54 Lafayette Place in the City of Auburn, New York; and

WHEREAS, 54 Lafayette Place is a vacant parcel located in an I: General Industrial zone and adjoining the R-2: Single-, Two-, and Multiple-Family Residential zone; and

WHEREAS, it is requested that the Council amend the Zoning Map of the City of Auburn such that 54 Lafayette Place, as shown on attached Exhibit A, be re-zoned R-2: Single-, Two-, and Multiple-Family Residential; and

WHEREAS, said review of the above action has been made in full compliance with Article 8 of the New York Conservation Law and the New York State Environmental Quality Review Act (SEQR), and the Auburn City Council has determined to prepare a Negative Declaration under SEQR for the proposed action.

NOW, THEREFORE, BE IT ORDAINED that the City Council of the City of Auburn, New York does hereby amend the Zoning Map of the City of Auburn whereby the real property situated at 54 Lafayette Place and shown on "Exhibit A," which is attached hereto and made part thereof, shall be classified as R-2: Single-, Two-, and Multiple-Family Residential rather than I: General Industrial, in order that these lands be consistent with the residential zoning of the adjacent area.

ORDINANCE #14 OF 2016

AMENDING THE SANITARY SEWER ORDINANCE OF THE CITY OF AUBURN, NEW YORK TO AMEND THE DEFINITION OF "PRETREATMENT REGULATIONS"

WHEREAS, Section 242 entitled "Sanitary Sewers" is cited as the Sanitary Sewer Ordinance of the City of Auburn, New York; and

WHEREAS, on November 14, 2005, the Environmental Protection Agency made changes to the general pretreatment regulations at 40 CFR Part 403 which included clarifications of existing regulations, specifically regarding significant noncompliance to instantaneous maximum limits and best managerial practices; and

WHEREAS, on November 20, 2014, the City of Auburn amended its sewer use ordinance including changes to the definition of significant noncompliance to include best

management practices, however, that amendment failed to include the clarification regarding instantaneous limits; and

WHEREAS, it is necessary that the City modify its definition of "significant noncompliance" by amending Section 242-79 of the sanitary sewer ordinance as follows:

- A. Chronic violations of wastewater discharge limits, defined here as those in which 66% or more of wastewater measurements taken during a six-month period exceed a [daily maximum limit or average limit] numeric pretreatment standard or requirement, including instantaneous limits, for the same pollutant parameter by any amount;
- B. Technical review criteria (TRC) violations, defined here as those in which 33% or more of wastewater measurements taken for each pollutant parameter during a six-month period equal or exceed the product of the [daily maximum limit or the average limit] numeric pretreatment standard or requirement, including instantaneous limits, multiplied by the applicable criteria (1.4 for BOD, TSS, fats, oils and grease, and 1.2 for all other pollutants except pH);

; and

WHEREAS, the term "significant noncompliance" shall mean:

Auburn should revise its definition of significant noncompliance to reflect the 2005 clarifications to the general pretreatment regulations at 40 CFR Part 403.

NOW, THEREFORE, BE IT ORDAINED that Section 242-79 of the Sanitary Sewer Ordinance of the City of Auburn, New York be amended to state as follows:

§242-79 Publication of users in significant noncompliance.

- A. Chronic violations of wastewater discharge limits, defined here as those in which 66% or more of wastewater measurements taken during a six-month period exceed a [daily maximum limit or average limit] numeric pretreatment standard or requirement, including instantaneous limits, for the same pollutant parameter by any amount;
- B. Technical review criteria (TRC) violations, defined here as those in which 33% or more of wastewater measurements taken for each pollutant parameter during a six-month period equal or exceed the product of the [daily maximum limit or the average limit] numeric pretreatment standard or requirement, including instantaneous limits, multiplied by the applicable criteria (1.4 for BOD, TSS, fats, oils and grease, and 1.2 for all other pollutants except pH);

; and

BE IT FURTHER ORDAINED that said amendments to the Ordinance shall become effective upon publication.

APPOINTMENT RESOLUTION #174 OF 2016

FOR AN APPOINTMENT OF COMMISSIONER OF DEEDS

WHEREAS, the Auburn City Council has appointed Commissioners of Deeds to allow a person the authority to take affidavits, depositions and acknowledgments of deeds for use in the City in which the person is appointed. The powers are similar to that of a Notary Public; and

WHEREAS, Section 139 of the Executive Law of the State of New York sets forth the authority and procedure for appointment of Commissioner of Deeds and those persons shall be appointed by the City Council for a designated term; and

WHEREAS, the term of each Commissioner of Deeds shall expire on the 31st of December of the even-numbered year next after he/she shall be appointed and there are requirements that the person receiving the designation must reside or work in the City of Auburn and can only administer the Commission within the City of Auburn. Those persons must file an Oath of Office with the City Clerk and with the County Clerk; and

WHEREAS, the Mayor and City Council are desirous of appointing Lieutenant James Slayton of the Police Department as a Commissioner of Deeds.

NOW THEREFORE BE IT RESOLVED that the Auburn City Council does hereby appoint Lieutenant James Slayton as a Commissioner of Deeds pursuant to the authority provided by Section 139 of the Executive Law of the State of New York and said appointment shall be effective from the date of approval of this Resolution and shall continue until December 31, 2016.
