FINANCIAL RESOLUTION #21 OF 2017

AUTHORIZING THE ACCEPTANCE OF GRANT MONIES FROM THE NYS DIVISION OF CRIMINAL JUSTICE SERVICES FOR THE POLICE PROTECTIVE EQUIPMENT PROGRAM

WHEREAS, the City of Auburn Emergency Response Team ("ERT") is an essential unit within the City of Auburn Police Department ("APD") specially trained to respond to and safely resolve critical incidents or active shooter events; and

WHEREAS, the APD announced in late 2016 that the ERT was in the process of being reactivated, upon which the 16 officers of the ERT would require updated advanced ballistic helmets, vest plates and patrol rifles in order to continue the high level of service they provide to the community and participate in mutual aid programs with the Cayuga County Sheriff's Office; and

WHEREAS, in November, 2016, the City of Auburn, in partnership with Cayuga County, submitted a grant application to NYS Division of Criminal Justice Services ("DCJS") for funding assistance towards the purchase of advanced ballistic helmets, vests and patrol rifles for the APD; and

WHEREAS, in January, 2017, the City of Auburn received notification of funding assistance from the NYS DCJS in the sum of \$46,255 under the Police Protective Equipment Program; and

WHEREAS, the Cayuga County Legislature will serve as the lead agency for the purposes of this funding opportunity and the City of Auburn will be the implementing agency; and

WHEREAS, the Mayor of the City of Auburn must be authorized to accept the grant funding and execute all necessary documents in connection therewith prior to commencing the project.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF AUBURN, NEW YORK:

1. That the Mayor, or approved representative, is authorized to execute any and all documents related to the grant assistance contract, submit project documentation, and otherwise act on all matters related to the project and state assistance; and

- 2. That the City Comptroller is authorized to recognize grant revenue and appropriate the funds into the State Aid Department of Criminal Justice Account (#A99.3394); and
- 3. That the City Comptroller is authorized to increase the Police Department FY 2016-17 equipment expense account (#A3120.250) in the grant award amount of \$46,255 for the acquisition of police protective equipment.

SUPPORTING THE ENACTMENT OF STATE LEGISLATION ALLOWING FOR THE ESTABLISHMENT OF RIDE SHARING TRANSPORTATION NETWORK COMPANIES IN UPSTATE NEW YORK

WHEREAS, under New York State law, popular ride-sharing transportation services, such as Uber and Lyft, are only legally permitted to operate in New York City, providing a fundamental imbalance in economic opportunity and access to cost-effective transportation that benefits New York City while hurting Upstate New York; and

WHEREAS, there is a long-standing and persistent need for alternative methods of transportation for the residents and visitors of Auburn and Cayuga County, to travel within the

region to destinations not easily accessible or served by public transportation such as airports, rail and bus stations; and

WHEREAS, Auburn and Cayuga County have a strong and growing tourism-based economy, with a large percentage of visitors who are accustomed to having access to ridesharing services and who expect that same level of service here in our City and region.

NOW, THEREFORE, BE IT RESOLVED, that the Auburn City Council supports the timely enactment of state legislation that would allow for ride sharing transportation network companies to be established and operated as soon as possible in the City of Auburn and County of Cayuga, as well as throughout the entire Upstate New York region; and,

Genesee Street Pavement account (HA99.2892.HN) to cover the local share cost of participation in the Design, Construction and/or Construction Supervision and Inspection phase of the Project, and it is further
- **RESOLVED,** that the Construction and/ or Construction Supervision and Inspection phase work be charged to the W. Genesee Street Pavement capital account (#HA5110.440.HN), and it is further

WHEREAS, Resolution No. 120 of 2013 approved the Project and authorized execution of a master agreement with the New York State Department of Transportation regarding administration and funding of Design (Phases I-VI) for a total cost of \$580,0000 and ROW Incidentals for a total cost of \$23,800; and,

WHEREAS, the City of Auburn desires to advance the above Project by making a commitment of 100% of the first instance payments of the total project costs in the amount of \$603,800 for Design and ROW Incidentals, and \$3,850,000 for Construction and/or Construction Supervision and Inspection phases for the Project.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Auburn does hereby approve the Project, and it is hereby

RESOLVED, to approve the project and authorize the City of Auburn to pay in the first instance 100% of the costs of Design, ROW Incidentals, Construction and/ or Construction Supervision and Inspection work for the Project or portions thereof in the amount of \$4,453,800, and it is further

RESOLVED, that the sum of \$210,190 is hereby made available for transfer from the General Fund Transfer to Capital if provided for in the City Budget or through the City's Annual Road Improvement Program to the Capital – North Division Street Bridge account (HA99.2892.HM) to cover the local share cost of participation in the Design, ROW Incidentals, Construction and/ or Construction Supervision and Inspection phase of the Project, and it is further

RESOLVED, that the Construction and/ or Construction Supervision and Inspection phase work be charged to the North Division Street Bridge capital account (#HA5110.440.HM), and it is further

RESOLVED, that in the event the full Federal- and non-Federal share costs of the project exceeds the amount appropriated above, the City of Auburn City Council shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation, and it is further

- **RESOLVED,** that the Construction and/ or Construction Supervision and Inspection phase work be charged to the North Hunter Brook Culvert capital account (#HA5110.440.HO), and it is further
- **RESOLVED,** that in the event the full Federal- and non-Federal share costs of the project exceeds the amount appropriated above, the City of Auburn City Council shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation, and it is further
