WHEREAS, in order for the Auburn Police Department to be in full compliance with the requirements set forth by DCJS, Chapter 221, Section 7, as amended, must be passed as a local law, instead of an ordinance; and

WHEREAS, the passage of Local Law No. 2 of 2017, is categorized as a Type II Action pursuant to the New York State Environmental Quality Review Act (SEQRA) and New York State Code, Rules, and Regulations Sections 617.5(c)(24), (25) and (27), and, therefore, pursuant to NYCRR Section 617.3(f) a determination under SEQRA is not required; and

WHEREAS, a public hearing was held on April 13, 2017, concerning the repeal of Local Law No. 2-1991, which adopted Chapter 221, Section 7, of the Auburn City Code and the enactment of Local Law No. 2 of 2017, which is attached hereto.

NOW, THEREFORE, BE IT ENACTED, that the Auburn City Council does hereby repeal that portion of Local Law No. 2-1991, passed on March 28, 1991, which adopted Chapter 221, Section 7, of the City Code; and

BE IT FURTHER ENACTED, that the Auburn City Council does hereby adopt Local Law No. 2 of 2017 as Chapter 221, Section 7 of the Auburn City Code entitled "Peddling and Soliciting; Investigation; Issuance of License; Appeals;" and

BE IT FURTHER ENACTED, that the foregoing repeal and adoption shall take effect immediately upon the filing of a certified copy of the local law with the New York Secretary of State.

LOCAL LAW #3 of 2017

REPEALING AND REPLACING CHAPTER 268 OF THE AUBURN CITY CODE ENTITLED "TAXICABS"

WHEREAS, on March 28, 1991, the Auburn City Council enacted and established Local Law No. 2-1991, which adopted Chapter 268 of the Auburn City Code entitled "Taxicabs" pursuant to New York State Municipal Home Rule Law Section 10; and

- **WHEREAS,** Chapter 268 of the Auburn City Code has been amended over the years approximately twenty-eight times by various ordinances; and
- **WHEREAS,** in order for the Auburn Police Department to implement the laws set forth in Chapter 268 of the City Code, it must comply with requirements set forth by the New York State Department of Criminal Justice Services ("DCJS"); and
- **WHEREAS**, in order for the Auburn Police Department to be in full compliance with the requirements set forth by the DCJS, the amendments to Chapter 268 of the City Code must be passed as a local laws, instead of an ordinances; and
- **WHEREAS**, the passage of Local Law No. 3 of 2017, is categorized as a Type II Action pursuant to the New York State Environmental Quality Review Act (SEQRA) and New York State Code, Rules, and Regulations Sections 617.5(c)(24), (25) and (27), and, therefore, pursuant to NYCRR Section 617.3(f), a determination under SEQRA is not required; and
- **WHEREAS,** a public hearing was held on April 13, 2017, concerning the repeal of Local Law No. 2-1991, which adopted Chapter 268 of the Auburn City Code, and the enactment of Local Law No. 3 of 2017, which is attached hereto.
- **NOW, THEREFORE, BE IT ENACTED,** that the Auburn City Council does hereby repeal that portion of Local Law No. 2-1991, passed on March 28, 1991, which adopted Chapter 268 of the City Code entitled "Taxicabs;" and

AGREEMENT RESOLUTION #60 OF 2017 APPROVING AN AGREEMENT FOR MUNICIPAL SOLID WASTE

WHEREAS, the City of Auburn operates a landfill and receives municipal solid waste and other items in connection with the operation of the solid waste landfill pursuant to the New York State Department of Environmental Conservation permitting; and

WHEREAS, it is necessary that a minimum amount of municipal solid waste is received annually to ensure financial stability for the solid-waste fund; and

WHEREAS, Morgan Rubbish Removal, Inc. and Dependable Disposal, LLC. owned by Steven R. Morgan has delivered municipal solid waste to the landfill for many years and is desirous of entering into an agreement for the deposit of the municipal solid waste for a term commencing August 1, 2016 through June 30, 2017; and

WHEREAS, the companies owned by Steven R. Morgan are hereafter referred to as "Morgan" and the Solid Waste Disposal Agreement between the City and Morgan will recognize municipal solid waste deposited by both firms and will set a volume that will be delivered to the landfill during the term of the agreement and further set forth a tipping fee and cost per ton to Morgan for the deposit of municipal solid waste, namely:

The cost per ton in this agreement shall be:

\$55.00 per ton for ton 0-50 \$35.00 per ton for tons 51-500 \$33.00 per ton for tons 501-1,000 \$31.00 per ton for 1,001 plus for the term of this agreement **NOW, THEREFORE, BE IT BE RESOLVED** that the Auburn City Council does hereby approve of a Solid Waste Disposal Agreement between the City of Auburn and Morgan Rubbish Removal, Inc. and Dependable Disposal, LLC., both of which are owned by Steven R. Morgan, and will allow an aggregate amount from both companies to be the subject matter of the solid waste disposal agreement; and

BE IT FURTHER RESOLVED that the Mayor of the City of Auburn is hereby authorized to sign the Solid Waste Disposal Agreement with Morgan Rubbish Removal, Inc. and Dependable Disposal, LLC. and that said agreement shall be effective as of August 1, 2016.
