COUNCIL RESOLUTION #72 OF 2017

ESTABLISHING A HEALTH INSURANCE INCENTIVE FOR CERTAIN RETIREES

WHEREAS, over the course of the last thirty years, the City Council of the City of Auburn has passed various resolutions and ordinances concerning the provision of health insurance benefits to certain retired City employees; and

WHEREAS, retirement incentives were provided to the Civil Service Employees Association ("CSEA"), Police and Fire collective bargaining units, by resolutions passed by the City Council of the City of Auburn on August 6, 1987, December 19, 1987, and December 22, 1987, which stated that employees who retire within the specified time periods, "shall be eligible for the benefits of a Retirement Incentive Program, which would provide that such employees

would receive medical insurance coverage and benefits in the same manner as active employees of the City of Auburn for the duration of their retirement;" and,

WHEREAS, certain management employees who retired between January 11, 1991, and December 19, 1997 under management ordinances passed by the City Council of the City of Auburn, which stated that, "Elected and appointed officials and management and confidential under Groups I, II and III that presently are allowed health insurance coverage by the City of Auburn shall be afforded upon retirement and/or leaving their positions with the City after ten (10) continuous years of service, continued health insurance benefits for the employee and the spouse of the employee, individual or family plan, for so long as either shall live, in the same manner as is provided for active employees of the City of Auburn; as is now established or as hereafter may be amended."; and,

WHEREAS, active City employees currently pay 15% of their respective health insurance premiums; and,

WHEREAS, pursuant to the resolutions and ordinances stated herein, certain retired City employees are now required to contribute 15% of the cost of their respective health insurance premium; and,

WHEREAS, the City would like to provide a mutually beneficial health insurance incentive to keep costs down for both the City and the aforementioned retirees; and

WHEREAS, the proposed incentive would provide full health insurance coverage to the aforementioned retired City employees with a 0% retiree premium contribution on the condition that the retiree and their spouse participate in the Medicare supplement health insurance plan offered by the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Auburn, that if the above referenced retired City employees and their surviving spouses, when applicable, agree to participate in the Medicare supplement plan in lieu of the traditional health insurance plans provided by the City, then the City shall agree to waive the otherwise required retiree health insurance premium contribution.

- 2) Improve Competitiveness in, and Connections to, the Regional, National and Global Economies through investment in 21st century infrastructure and human capital;
- 3) Revitalizing our Region's Urban Cores, Main Streets and Neighborhoods through partnerships with anchor institutions and tomorrow's workforce; and

WHEREAS, the Downtown Revitalization Initiative funding would facilitate the implementation of key catalytic projects in Auburn, which will ultimately support the

community's vision to make downtown Auburn a place where future generations can work, recreate, and raise their families.

WHEREAS, on September 26, 2016, the City of Auburn observed detectable levels of toxins associated with harmful blue green algae blooms in its raw and finished (treated) water; and

WHEREAS, on April 26, 2017, Governor Andrew M. Cuomo signed the Clean Water Infrastructure Act of 2017, which provides reimbursement in the amount of \$600,000 to the City of Auburn to fund a temporary powder activated carbon treatment system to immediately treat the toxins associated with the seasonal harmful algae blooms in Owasco Lake; and

WHEREAS, on April 27, 2017, the Auburn City Council passed Financial Resolution #61 of 2017, authorizing a water fund transfer in the amount of \$600,000 to fund the Water Filtration Plant Microcystin Treatment and Water Quality Improvement Project (hereinafter referred to as "The Project") in order to fund the immediate purchase and implementation of a temporary powder activated carbon treatment system; and

WHEREAS, on May 12, 2017 the City of Auburn received a grant award in the amount of \$600,000 from New York State Environmental Facilities Corporation ("EFC") to fund the construction and engineering of the temporary powder activated carbon treatment system and demonstration study for The Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, New York, hereby accepts grant funding from the New York State Environmental Facilities Corporation in the amount of \$600,000 to fund the Water Filtration Plant Microcystin Treatment and Water Quality Improvement Project, to be recorded into the Water Filtration Plant Microcystin Treatment - State Aid Account (HF99.359.IH); and

BE IT FURTHER RESOLVED that the Mayor of the City of Auburn, or a designated representative, is authorized to execute the grant assistance contract, submit project documentation, and otherwise act on all matters related to the Water Filtration Plant Microcystin Treatment and Water Quality Improvement Project and State assistance.

WHEREAS, New York General Municipal Law Section 103(5) reads as follows:

Upon the adoption of a resolution by a vote of at least three-fifths of all the members of the governing body of a political subdivision or district therein stating that, for reasons of efficiency or economy, there is need for standardization, purchase contracts for a particular type or kind of equipment, material, supplies or services in excess of the monetary threshold fixed for purchase contracts in this section may be awarded by the appropriate officer, board or agency of such political subdivision or any such district therein, to the lowest responsible bidder or responsible offerer furnishing the required security after advertisement for sealed bids or sealed offers therefore in the manner provided in this section. Such resolution shall contain a full explanation of the reasons for its adoption; and

WHEREAS, it has been determined that the Sensus Residential Water Meters (5/8", 3/4", & 1") should be standardized in order to create efficiencies and economies for the reasons set forth herein in Attachment A.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn authorizes the standardization of the services and materials outlined in attachment A.

WHEREAS, the City is presently reviewing the City Code, Section 305, entitled Zoning, in preparation of comprehensive zoning code revisions, and Bergmann Associates, the City's Brownfield Opportunity Area (BOA) consultant, is completing the review and revisions as a component of the Auburn SPARKS planning process; and

WHEREAS, the Section 305 of the City Code, as it will be amended, will include a prohibition on billboards in order to bring the City Code in line with the goals of the Comprehensive Plan; and

WHEREAS, the City anticipates completing the comprehensive zoning code revisions within the next six months; and

WHEREAS, the Auburn City Council is authorized to adopt a moratorium pursuant to New York General City Law Sections 19 and 20;

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby impose a six (6) month moratorium, effective immediately, upon the acceptance and review of new applications seeking approval for the issuance of permits, and the construction and installation of advertising signs, commonly referred to as billboards, in order to provide the City an opportunity amend the City Code so that it aligns with the goals of the Comprehensive Plan.
