A. City Manager's Report

- Auburn Fire Department is out flowing and testing hydrants in the city. This will be going on throughout the months of July, August and September. There may be wet spots in the road or on the sidewalks and possibly some discolored water. The hydrant maintenance is conducted twice annually as both a best practice and also to help must maintain favorable ISO ratings that can impact property insurance rates.
- Last Wednesday I attended a Coffee with a Cop event hosted by the Grant Avenue McDonalds. The event was well attended and is going to be followed up by another Coffee with a Cop event at the Grant Avenue McDonalds on July 19 from 8-10am.
- The street lights are out on the Lake Ave. Bridge. The DPW is aware of the issue and is investigating the cause so that a repair can be made soon.
- The heavy rains over this past weekend have caused the river flows to be very high. John west has been doing a great job attempting to keep the Owasco Lake level under control while also taking into consideration the impact our release has on downstream residents in Port Byron. The lake level should return to normal over the next couple of days depending on how much new rain falls.
- The new 2 hour free parking program has begun at the parking garage. New signage has been placed at the entrance and additional new signage will continue to be installed. The street level spaces along the rear exit of the parking garage have now been converted to metered spots along with signage to inform the public of the change. Enforcement of those meters is scheduled to begin July 16. The automation equipment for the garage has been ordered and will likely be installed by the end of July.

WHEREAS, that Policy updated benefits and compensation, established a salary schedule that provides for a defined progression of steps tied to performance and longevity, and addressed the potential wage and benefit compression and disparity that can occur between non-represented managers and their subordinate employees who are represented by collective bargaining agreements; and

WHEREAS, the Policy further addresses the designation of work weeks, compensatory time and overtime, vacation, holiday, personal leave, sick leave and insurance benefits, among other items for the class of employees; and

WHEREAS, new collective bargaining agreements have health insurance provisions in them which create savings for the City and for the employees, and the City is desirous of offering these health insurance related provisions to employees serving under the Senior Management Personnel Policy to benefit both the City and the employees.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby amend the Senior Management Personnel Policy which has been approved by the Auburn City Council on January 21, 2016 and the policy shall become effective as of July 1, 2017 and remain in full force and effect until December 31, 2017.

WHEREAS, Wilmington Savings Fund, FSB has offered the additional sum of eight thousand dollars (\$8,000) in order to obtain title to the premises and conveying the property to Lender will relieve the City of the responsibility of maintenance and liability for the property and a sale to the Lender will place the property back on the tax rolls and the payment of the delinquent tax amount and the additional offer is reasonable consideration due to the condition of the property; and

WHEREAS, 33 Pulaski Street is surplus property no longer needed for City purposes.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the sale of a parcel known as 33 Pulaski Street to Wilmington Savings Fund, FSB, doing business as Christina Trust, not in its individual capacity, but solely as trustee for BCAT2015-14BTT for the additional sum of \$8,000 and the Mayor is authorized to sign any and all documents in order to finalize the transfer.
