AUTHORIZING A 2017 NYS CONSOLIDATED FUNDING APPLICATION (CFA) FOR WATER QUALITY IMPROVEMENTS AT THE AUBURN WASTEWATER TREATMENT PLANT

WHEREAS, the City of Auburn owns and operates a municipal wastewater treatment facility that provides treatment services for nearly 40,000 residents located in the City of Auburn and the Towns of Aurelius, Fleming, Owasco and Sennett; and

WHEREAS, the City of Auburn acknowledges the importance of water quality as it relates to the City's goals of disinfecting wastewater prior to discharge, utilizing advance technologies to preserve the environment, and community-wide sustainability; and

WHEREAS, the 2017 New York State Consolidated Funding Application (CFA) has released a request for proposals for water quality improvement projects from eligible municipalities; and

WHEREAS, the City of Auburn intends to apply for 2017 CFA funding to upgrade the wastewater treatment effluent disinfection system to meet NYS DEC SPEDS permit requirements; and

WHEREAS, water quality improvement projects align with the Central New York Regional Economic Development Council's *Five-Year Strategic Plan: 2012-2016* priority goals as well as supporting industry growth in the region's opportunity agenda and strategic plan; and

WHEREAS, the Auburn Wastewater Treatment Plant Improvement Project would consist of the installation of new Ultraviolet (UV) technology that would improve the effluent disinfection of the Plant, which has an anticipated cost of \$1,920,000, with a maximum grant amount of \$1,000,000 and the balance to consist of local match of \$920,000 to be made available in the City's Sewer Fund; and

WHEREAS, the City of Auburn does not currently have the funding to pay for 100% of the Wastewater Treatment Plant Improvement Project and it is necessary to obtain New York State funding assistance for the project development and implementation.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn, New York:

- 1. That the Mayor, or appointed designee, is authorized to submit an application for funding under the 2017 CFA to implement a water quality improvement project at the Auburn wastewater treatment plant in an amount not to exceed \$1,920,000 in total project costs; and
- 2. That the Mayor, or appointed designee, is also authorized, if awarded, to execute the grant assistance contract, submit project documentation, and otherwise act for the Municipality's governing body in all matters related to the project and state assistance; and
- 3. That the City Comptroller is authorized to recognize grant revenue, if awarded, and to appropriate the funds into the designated departmental or capital account(s).
- 4. That this resolution shall take effect immediately upon its adoption.

COUNCIL RESOLUTION #1110F 2017

AUTHORIZING A 2017 NYS CONSOLIDATED FUNDING APPLICATION (CFA) FOR A LOCAL WATERFRONT REVITALIZATION PROGRAM PROJECT TO PLAN AND DESIGN THE RIVERSIDE REGIONAL PUBLIC MARKET

WHEREAS, the City of Auburn prepared and submitted Downtown Revitalization Initiative (DRI) applications to New York State in 2016 and 2017; and

WHEREAS, the City included a Riverside Regional Public Market in the DRI application, which will be a transformative project that will attract and retain residents, visitors and businesses; and

WHEREAS, in addition to the DRI program, the City of Auburn desires to pursue alternative funding sources to move this project forward; and

WHEREAS, the 2017 New York State Consolidated Funding Application (CFA) has released a request for proposals for Local Waterfront Revitalization Program projects for which municipalities are eligible to apply; and

WHEREAS, the City of Auburn's local waterfront revitalization project aligns with the Central New York Regional Economic Development Council's *Five-Year Strategic Plan: 2012-2016* priority goals of Revitalizing Urban Cores, Main Streets, and Neighborhoods; and

WHEREAS, the planning, design and construction documents for the Riverside Regional Public Market have an anticipated cost of \$600,000; and

WHEREAS, the City of Auburn is requesting \$450,000 in funding assistance from the NYS Environmental Protection Fund Local Waterfront Revitalization Program, and will make available the required local match of 25%, or \$150,000 from the City General Fund; and

WHEREAS, the City of Auburn does not currently have the funding to pay for 100% of the planning and design for the Riverside Regional Public Market and it is necessary to obtain New York State funding assistance for the project development and implementation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Auburn, New York:

- 1. That the Mayor, or appointed designee, is authorized to submit an application for funding under the 2017 CFA to implement a Local Waterfront Revitalization Program project in an amount estimated at \$600,000 in total project costs; and
- 2. That the City of Auburn is requesting \$450,000 in funding assistance from the NYS Environmental Protection Fund Local Waterfront Revitalization Program, and would make available the required local match of 25%, or equal to \$150,000, from the City General Fund; and
- 3. That the Mayor, or appointed designee, is also authorized, if awarded, to execute the grant assistance contract, submit project documentation, and otherwise act for the Municipality's governing body in all matters related to the project and state assistance; and
- 4. That the City Comptroller is authorized to recognize grant revenue, if awarded, and to appropriate the funds into the designated departmental or capital account(s).
- 5. That this resolution shall take effect immediately upon its adoption.

WHEREAS, the water quality of Owasco Lake is important to the City of Auburn and its residents; and

WHEREAS, Cayuga County is in the process of constructing Phase I of the Owasco Flats Wetland Restoration and Riparian Buffers Initiative Project, and

WHEREAS, the City of Auburn, NY owns the property located within the Owasco Flats where the phase I construction activities are being implemented; and

WHEREAS, this project will provide measurable pollution removal within the watershed of Owasco Lake, which is an important scenic asset, offers a wide variety of recreational opportunities which contribute to the local economy, and provides drinking water for nearly 50,000 people; and

WHEREAS, Cayuga County will be submitting a grant proposal to the New York State Environmental Facilities Corporation Green Innovative Grant Program (GIGP) for the Owasco Flats Wetland Restoration and Riparian Buffers Initiative Project Phase 2 with an estimated project cost of \$600,000; and

WHEREAS, the City of Auburn, NY owns the property identified as tax map parcels #198.00-1-3 and 198.00-1-8 in the Town of Moravia, where the phase 2 project is proposed; and

WHEREAS, the City of Auburn City Council fully supports these efforts to continue to implement and invest in nutrient and sediment capture and removal in the Owasco Lake Watershed.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Auburn, New York:

- 1. That the City of Auburn supports Cayuga County's efforts to submit an application through the 2017 NYS CFA GIGP for purposes of funding phase 2 of the Owasco Flats Wetland Restoration and Riparian Buffers Initiative Project at an estimated cost of \$600,000; and
- 2. The City Clerk shall forward a certified copy of this resolution to Cayuga County to include the resolution in its grant application.
