was before the Council regarding the project.

Stephanie DeVito, Executive Director, Auburn Downtown Business Improvement

Ms. DeVito provided an overview of activities that will be conducted over the weekend of September 8-10, 2017 as part of the annual CNY Tomatofest which is being held for the second year in a row in Downtown Auburn.

8. Reports of City Officials

A. City Manager's Report

- Court St. Parking Lot update: If tonight's resolution to proceed with the Court St. Parking Lot expansion passes, work to expand the lot will take place with the intent of substantial completion by winter. The expansion is anticipated to include new lighting, run off control, and landscaping to reduce the visual impact and aid in run off control.
- The long awaited Owasco River Greenway Trail project is kicking off this week. There is a project office set up on Canal St. and work along Canal St. and Miller St. will be underway in the next few days. The project limits are from the Mill St. Dam to State St. and is scheduled to conclude in June of 2018.
- The Request for Qualifications for the Environmental Assessment and Design for 1-7 State Street was released August 18th. All proposals were due Tuesday Sept. 5th. Six proposals have been received and will be reviewed and scored next week. The Scope of Work includes the preparation of a detailed design for a public park space. The conceptual design must be sensitive to the existing buildings and the surrounding community as well as public input received. In addition the Scope of work includes review and update of the Phase I document for the site and Phase II Investigation. It is anticipated that the design work will be completed in time for construction to begin in the spring of 2018.
- The City currently owns about 75 parcels that are considered vacant or undeveloped. If tonight's proposal to update the City Land Sale Policy is accepted, I would like to explore systematically reviewing these parcels with Council and our Departments Heads to determine which parcels should be retained by the City and which ones we should attempt to get back on the tax rolls.
- Work to repair the damaged floor of a settling tank at the Waste Water Treatment plant began this week.
- A section of 10" sewer main on Franklin St. near Cayuga St. has been identified as damaged and in need of immediate repair to avoid local backups. Tomorrow morning after the school buses have completed their rounds the sewer crew will be detouring traffic in the area to work on the issue.

• The Powder Activated Carbon system was utilized last weekend after low levels of microcystin were detected in the raw water. The system operated throughout the weekend and performed well. The last two readings of raw water did not detect any microcystin and the PAC system has been shut down.

WHEREAS, the proposed revisions to the Code of the City of Auburn may impact land use regulations citywide, thereby designating the project a *Type 1 Action*; and

WHEREAS, pursuant to the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, as amended (the "Regulations"), the City desires to comply with the SEQR Act and the Regulations and will be required to review the above *Type I Action*; and

WHEREAS, the New York State Department of State and the City of Auburn Planning Board may be considered Involved Agencies in such review with respect to approval of or funding for the project;

- 5. Janet Street from Tuxill Square to Logan Street Paving including sewer repair Estimated cost – \$62,000

COUNCIL RESOLUTION #134 OF 2017

AUTHORIZING A HEALTH INSURANCE BUYOUT INCENTIVE TO CERTAIN RETIREES

WHEREAS, certain retirees maintain two sources for health insurance, one of which is City health insurance, because they have a City health insurance bank which they do not want to lose; and,

WHEREAS, offering a buyout of this health insurance bank to retirees, who are interested, is a sustainability measure for the City and financially beneficial to those retirees; and,

WHEREAS, the City is desirous of offering a cash payment of 50% of a retiree's health insurance bank up to a total payment of \$25,000 in consideration for the retiree irrevocably waiving their right to City health insurance.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn authorizes the Comptroller to enter into a health insurance bank buyout incentive with interested retirees in the form of a cash payment at 50% of the value of the retiree's health insurance bank, up to a total payment of \$25,000, in consideration for the retiree irrevocably waiving their rights, in writing, to City health insurance.

BE IT FURTHER RESOLVED that:

- This resolution shall take effect immediately upon its adoption and shall remain in effect unless amended or rescinded by the City Council at their discretion; and,

WHEREAS, on August 3, 2016, the City of Auburn entered into a Joint Funding Agreement partnering with the U.S. Geological Survey ("USGS") (the "Agreement"); and

WHEREAS, the Agreement provides necessary field and analytical work in order to collect critical data, namely the maps, records and reports, so that the City of Auburn can maintain the river flows in accordance with the Wastewater SPDES permit, operate the City's hydroelectric facilities and maintain Owasco lake elevations per the U.S. Army Corp Rule Curve; and

WHEREAS, the existing agreement expires on September 30, 2017; and

WHEREAS, the USGS has proposed entering into a new agreement in order to continue project activity, which will commence on October 1, 2017, and terminate on September 30, 2018; and

WHEREAS, the work performed costs a total amount of \$24,260, of which \$7,280 is contributed by the U.S. Geological Survey and \$16,980 is contributed by the City of Auburn; and

WHEREAS, the cost incurred by the City of Auburn is set forth annually in the operating budget for the Water Filtration Plant.

NOW, THEREFORE, BE IT RESOLVED that the Mayor is hereby authorized to enter into the Joint Funding Agreement For Water Resource Investigations with the U.S. Geological Survey, U.S. Department of the Interior, for a period of time commencing October 1, 2017 to September 30, 2018; and

BE IT FURTHER RESOLVED that the total expenditure under the Joint Funding Agreement For Water Resource Investigations shall be the amount of \$24,260, of which \$7,280 shall be contributed by the U.S. Geological Survey, and \$16,980 shall be contributed by the City of Auburn through the annual operating budget (Water Filtration Plant Services Account Number F8330.440).
