About the 1-7 State Street Project...

The 1-7 State Street project is an environmental investigation and detailed site design for a vacant and underutilized city owned site on State Street. The project includes the preparation of a Phase I Environmental Site Assessment, a Sampling Plan for Phase II investigation and conducting Phase II/Remedial Investigations.

The City of Auburn and the project team will be engaging stakeholders and community members to provide input on the design for the public park space. By the end of the process, a Phase I assessment report and a Phase II report with remediation recommendations will be completed

along with detailed construction drawings for the site. Services for these projects are being funded fully through the US Department of HUD Community Development Block Grant Program, administered by the City of Auburn.

5. Ceremonial Presentations and Proclamations The City Clerk read the following proclamation from the Office of Mayor Michael D. Quill.

WHEREAS, the City of Auburn, NY is committed to ensuring the safety and security of all those living in and visiting Auburn; and

WHEREAS, U.S. fire departments responded to 365,500 home fires in 2015, according to the National Fire Protection Association (NFPA); and

WHEREAS, U.S. home fires resulted in 2,560 civilian deaths in 2015, representing the majority (78 percent) of all U.S. fire deaths; and

WHEREAS, newer homes are built with lightweight materials that burn faster than older home constructions; and

WHEREAS, many of today's products and furnishings produce toxic gases and smoke when burned, making it impossible to see and breathe within moments; and

WHEREAS, these conditions contribute to a much smaller window of time for people to escape a home fire safely, with people having as little as one to two minutes to escape from the time the smoke alarm sounds; and

WHEREAS, a home fire escape plan provides the skill set and know-how to quickly and safely escape a home fire situation; and

WHEREAS, a home fire escape plan includes two exits from every room in the home; a path to the outside from each exit; smoke alarms in all required locations; and a meeting place outside where everyone in the home will meet upon exiting; and

WHEREAS, home fire escape plans should be developed by all members of the household; and

WHEREAS, practicing a home fire escape plan twice a year ensures that everyone in the household knows what to do in a real fire situation;

WHEREAS, Auburn's first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

WHEREAS, Auburn's residents are responsive to public education measures and are able to take personal steps to increase their safety from fire, especially in their homes; and

WHEREAS, the 2017 Fire Prevention Week theme, "Every Second Counts: Plan 2 Ways Out!" effectively serves to educate the public about the vital importance of developing a home fire escape plan

with all members of the household and practicing it twice a year;

NOW THEREFORE, I, Michael Quill, Mayor of the City of Auburn, on behalf of the City Council and the Citizens of Auburn, do hereby proclaim October 8-14, 2017, as

FIRE PREVENTION WEEK

throughout the community. I urge all the people of Auburn to develop a home fire escape plan, with all members of the household. Practice it twice a year, and to participate in the many public safety activities and efforts of Auburn's fire and emergency services during Fire Prevention Week 2017.

SEQR RESOLUTION #146 of 2017 ISSUING A NEGATIVE DECLARATION FOR THE EQUAL RIGHTS HERITAGE CENTER PROJECT

WHEREAS, the City Council of the City of Auburn, New York, in partnership with New York State Office of Parks, Recreation & Historic Preservation, intends to construct a new 7,500 sq. ft. Equal Rights Heritage Center in downtown Auburn, NY together with on-site and off-site improvements on approximately 2 acres of city owned property; and

WHEREAS, on August 17, 2017, the City Council declared itself Lead Agency for the purposes of completing a Coordinated Environmental Review for the Equal Rights Heritage Center project, formerly known as, the Cultural Heritage Center or CNY Welcome Center; and

WHEREAS, a review of the above Type I Action has been made in full compliance with Article 8 of the New York Conservation Law and the New York State Environmental Quality Review Act (SEQRA); and

WHEREAS, in addition to the information in the Full Environmental Assessment Form Part 1, said review considered the following documents:

• NYSHPO Letters dated 9/26/2017 and 8/31/2017,

- Stormwater Pollution Prevention Plan Cultural Heritage Center September 2017,
- Subsurface Investigation and Geotechnical Evaluation CNY Welcome Center May 26, 2017,
- Phase 1A Archaeological Survey Cultural Heritage Center May 2017,
- Parking Usage Study CNY Welcome Center April 2017, and
- Traffic Impact Study CNY Welcome Center April 2017; and

WHEREAS, said review has resulted in a reasoned determination that the proposed action will NOT result in any large and important impact(s) and, therefore, is one which will not have a significant negative impact on the environment;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn, that a NEGATIVE DECLARATION for the proposed action be prepared in full compliance with Article 8 of the New York State Environmental Conservation Law.

SEQRA RESOLUTION #147 OF 2017 NORTH STREET WATER MAIN REPLACEMENT PROJECT AMENDMENT OF SEQRA RESOLUTION # 46 OF 2016 DETERMINING THAT THE PROPOSED ACTION IS A TYPE II ACTION PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT

WHEREAS, on April 7, 2016 the Auburn City Council (the "City) adopted SEQRA Resolution No. 46 of 2016 determining a Type II action for proposed improvements to the water distribution system on North Street (NYS Route 34); and

WHEREAS, the City desires to undertake additional improvements to the existing water main located on York Street from the intersection of Willey Street west to Chase Street Ext., that would be completed under the NYS Environmental Facilities Corporation funded North Street Water Main Replacement Project; and

WHEREAS, the additional improvements to the York Street water main would involve replacement of the existing water main to provide reliable water service to the industrial customers in this area of the City; and

WHEREAS, Pursuant to the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted by the New York State Department of Environmental Conservation ("NYSDEC"), being 6 NYCRR Part 617 as amended (the "Regulations"), the City desires to comply with the SEQR Act and the Regulations with respect to the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY COUNCIL OF THE CITY OF AUBURN AS FOLLOWS:

- The City Council hereby amends SEQRA Resolution No. 46 of 2016 to include the replacement of additional water main located on York Street from Willey Street west to Chase Street Ext. to the NYS EFC funded North Street Water Main Project.
- 2. The Project constitutes a "Type II Action" under 6 NYCRR § 617.5 (c) (1) and (5) and no further action under the SEQR Act and Regulations is required.

BOND ORDINANCE #3 OF 2017

BOND ORDINANCE OF THE CITY OF AUBURN, NEW YORK, AUTHORIZING THE ISSUANCE OF ADDITIONAL SERIAL BONDS TO FINANCE THE COST OF THE RECONSTRUCTION OF THE CITY WATER DISTRIBUTION SYSTEM

WHEREAS, the Council of the City of Auburn, New York, on April 7, 2017 adopted Bond Ordinance No. 3 of 2016 entitled "BOND ORDINANCE OF THE CITY OF AUBURN, NEW YORK, AUTHORIZING THE ISSUANCE OF \$1,045,000 SERIAL BONDS TO

FINANCE THE COST OF THE RECONSTRUCTION OF THE CITY WATER DISTRIBUTION SYSTEM"; and

WHEREAS, the City Council wishes to (i) authorize the expenditure and appropriation of additional funds in connection with the reconstruction of the City water distribution system, and (ii) authorize the issuance of additional serial bonds of the City to finance such additional appropriation;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Auburn, New York as follows:

- <u>Section 1</u>. The City of Auburn, New York (the "City") is hereby authorized to undertake the reconstruction of the City's water distribution system, including the reconstruction and improvement of the existing water distribution main on NYS Route 34, including a portion of York Street, and the acquisition of replacement furnishings, equipment, machinery or apparatus required for the purposes for which such water distribution system are to be used at an estimated maximum cost of \$2,200,000, constituting an increase of \$1,155,000.
- <u>Section 2</u>. The plan for financing of such new maximum authorized cost of \$2,200,000 shall be as follows:
 - (a) by the issuance of \$1,045,000 of serial bonds of the City hereto were authorized to be issued pursuant to Bond Ordinance No. 3 of 2016 adopted by the City Council on April 7, 2016; and
 - (b) by the issuance of an additional \$1,155,000 of serial bonds (the "Bonds") of the City authorized to be issued pursuant to this Ordinance.
- Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty (40) years pursuant to paragraph 1 of Section 11.00(a) of the Local Finance Law; provided, however, that the maximum maturity of the Bonds shall be computed from the date of issuance of the Bonds or the first bond anticipation note issued in anticipation of the Bonds or the serial bonds or bond anticipation notes authorized pursuant to Bond Ordinance No. 3 of 2016, whichever date is earlier.
- <u>Section 4</u>. Pursuant to Section 107.00(d)(3)(a) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.
- <u>Section 5</u>. The temporary use of available funds of the City, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this Ordinance.
- <u>Section 6</u>. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law

and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the City, payable as to both principal and interest by a general tax upon all the real property within the City without legal or constitutional limitation as to rate or amount. The faith and credit of the City are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the City by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this Ordinance and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for level or substantially level or declining annual debt service, is hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.

Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this Ordinance shall be from the City's Water Fund. It is intended that the City shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this Ordinance and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This Ordinance is intended to constitute the declaration of the City's "official intent" to reimburse the expenditures authorized by this Ordinance with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Regulation Section 1.150-2. Other than as specified in this Ordinance, no moneys are reasonably expected to be, received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this Ordinance are hereby authorized to be consolidated, at the option of the City's Comptroller, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other bond ordinances previously or hereafter adopted by the City Council for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such ordinances. All matters regarding the sale of the bonds, including the date of the bonds, the consolidation of the serial bonds and the bond anticipation notes with other issues of the City and the serial maturities of the bonds are hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.

Section 10. Any federal or New York State grant funds obtained by the City for the capital purposes described in Section 1 of this Ordinance shall be applied to pay the principal of and interest on the Bonds or any bond anticipation notes issued in anticipation of the Bonds, the serial bonds or bond anticipation notes authorized pursuant to Bond Ordinance No. 3 of 2016, or to the extent obligations shall not have been issued under this Ordinance or Bond Ordinance

No. 3 of 2016, to reduce the maximum amount to be borrowed for such capital purposes. The City Comptroller, as Chief Fiscal Officer, is hereby authorized to determine the application of any such federal or New York State grant funds for any one or more of the foregoing purposes.

- Section 11. The City Comptroller, as Chief Fiscal Officer of the City, is further authorized to sell all or a portion of the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, to the New York State Environmental Facilities Corporation (the "EFC") in the form prescribed in one or more loan and/or grant agreements (the "Agreements") between the City and the EFC; to execute and deliver on behalf of the City one or more Agreements, project financing agreements, and letters of intent with the EFC and to accept the definitive terms of one or more Agreements from EFC by executing and delivering one or more terms certificates; and to execute such other documents, and take such other actions, as are necessary or appropriate to obtain a loan or loans from the EFC for all or a portion of the costs of the expenditures authorized by this Ordinance, and perform the City's obligations under its Bonds or bond anticipation notes delivered to the EFC, the project financing agreements and the Agreements.
- <u>Section 12</u>. The validity of the Bonds authorized by this Ordinance and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:
 - (a) such obligations are authorized for an object or purpose for which the City is not authorized to expend money; or
 - (b) the provisions of law which should be complied with at the date of the publication of this Ordinance or a summary hereof are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or
 - (c) such obligations are authorized in violation of the provisions of the Constitution.
- <u>Section 13</u>. The City Comptroller, as Chief Fiscal Officer of the City, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the City to provide secondary market disclosure as required by United States Securities and Exchange Commission Rule 15c2-12.
- <u>Section 14</u>. This Ordinance, or a summary of this Ordinance, shall be published in the official newspapers of the City for such purpose, together with a notice of the Clerk of the City in substantially the form provided in Section 81.00 of the Local Finance Law.
 - <u>Section 15</u>. This Ordinance is not subject to a mandatory or permissive referendum.
- <u>Section 16</u>. The Council hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Ordinance.

Section 17. This Ordinance shall take effect immediately upon its adoption.

COUNCIL RESOLUTION #148 OF 2017

AUTHORIZING ADVERTISEMENT FOR BIDS FOR THE EQUAL RIGHTS HERITAGE CENTER

WHEREAS, Council Resolution #105 of 2016 authorized City staff to submit an application to New York State Department of State (NYS DOS) Local Waterfront Revitalization Program (LWRP) for funding assistance to plan and design a Downtown Visitor Welcoming Center; and

WHEREAS, the City of Auburn was awarded 2016 EPF Grant #C1000920 from New York State Department of State for the design of the Downtown Visitor Welcoming Center, now known as the Equal Rights Heritage Center; and

WHEREAS, on March 2, 2017 the Auburn City Council passed Agreement Resolution #39 of 2017 awarding nARCHITECTS a contract in the amount of \$1,049.512.60 to provide Program Verification, Schematic Design, Design Development, Construction Documents, Bid and Award, and Construction Administration related to the Equal Rights Heritage Center; and

WHEREAS, nARCHITECTS is in the final design phase, and the project is now entering the construction bidding phase; and

WHEREAS, the City of Auburn submitted an application to New York State Empire State Development (ESD) through the Upstate Revitalization Initiative (URI) Program to complete the advanced design documents and construction of the Equal Rights Heritage Center; and

WHEREAS, on May 19, 2017, the City of Auburn received an Incentive Proposal in the amount of \$10,000,000 from ESD; and

WHEREAS, on September 15, 2017, Lt. Governor Kathy Hochul officially announced the location of the Equal Rights Heritage Center in Downtown Auburn and \$10,000,000 in construction funding through the URI Program; and

WHEREAS, permission is requested that the City Manager be authorized to advertise for bids for the Equal Rights Heritage Center.
