• There was a public meeting to share ideas for the proposed public space at 1-7 State St. on Monday October 16, 2017 at 6:30pm at the Hilton Garden Inn. Over 80 people attended the meeting including 26 students from the Blueprint program. There will be a follow up report on this meeting presented to the Council on October 26, 2017.

## **B.** Reports from members of Council

- Mayor Quill was notified by the Insurance Services Office (ISO) that the City of Auburn Fire Department, Water Supply and Communication Systems has received a Public Protection Classification (PPC) of 1. The PPC scale runs from Class 1 10 with Class 1 at the top of the list and Class 10 not meeting the minimum Fire Suppression Rating Schedule (FSRS) criteria for recognition. ISO is the leading supplier of data and analysis for the property / casualty insurance industry. Most insurers use PPC classifications for underwriting and calculating premiums for residential, commercial and industrial properties. The Mayor recognized the Fire Chief, Joe Morabito and the Chief spoke about the efforts that went into the achievement.
- Councilor Cuddy provide an update on the last meeting of the Cayuga County Lead Task Force that he and Jennifer Haines attended. The City's Assistant Corporation Counsel also attended and he provided some good information, he also plans to attend the next task force meeting.
- Councilor Giannettino discussed the Domestic Violence Awareness Month proclamation

## AWARD RESOLUTION #153 OF 2017 AWARDING A BID FOR THE 2017 LANDFILL SITE IMPROVEMENTS FOR FINAL CLOSURE

**WHEREAS,** on May 17, 2017, and on August 15, 2017, the NYS DEC inspected active Landfill No. 2, and concluded that measures be taken to prepare side slopes for final closure and to place intermediate cover in areas to mitigate leachate outbreaks in the vicinity of the side slopes; and

**WHEREAS,** this work is necessary to comply with the DEC approved Site Work Plan and Implementation Schedule submitted on June 16, 2017, and

WHEREAS, on September 11, 2017, the City advertised for competitive bids for the aforementioned work; and

**WHEREAS,** on October 4, 2017, bids were opened for the 2017 Landfill Site Improvements for Final Closure and the following bids were received:

**WHEREAS**, it is necessary that the Auburn City Council award the 2017 Landfill Site Improvements for Final Closure to the lowest responsible bidder, Adhan Piping Co. of Cortland, New York, which has submitted the low bid of \$269,900, and

WHEREAS, it is necessary to reallocate post-closure costs to the closure cost account to ensure sufficient funding, and

WHEREAS, the reallocation of funding does not increase the overall Solid Waste budget.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award the contract for the 2017 Landfill Site Improvements for Final Closure to the lowest responsible bidder, Adhan Piping Company of Cortland, New York, in the amount of \$269,900; and

**BE IT FURTHER RESOLVED**, that the Auburn City Council authorizes the City Comptroller to transfer \$69,900 from the Solid Waste Post-Closure Account (AL8168.552) to the Solid Waste Closure Account (AL8167.551), and that the cost of this award shall be charged to the Solid Waste Closure Account (AL8167.551).

## ACCEPTING A GRANT FROM EMPIRE STATE DEVELOPMENT FOR CONSTRUCTION OF THE EQUAL RIGHTS HERITAGE CENTER

**WHEREAS,** Council Resolution #148 of 2017 authorized the City Manager to advertise for construction bids for the Equal Rights Heritage Center, previously known as the Cultural Heritage Center; and

WHEREAS, the City of Auburn submitted an application to New York State Empire State Development (ESD) through the Upstate Revitalization Initiative (URI) Program to complete the advanced design documents and construction of the Equal Rights Heritage Center; and

**WHEREAS,** on May 19, 2017, the City of Auburn received an Incentive Proposal in the amount of \$10,000,000 from ESD; and

**WHEREAS,** on September 15, 2017, Lt. Governor Kathy Hochul officially announced the location of the Equal Rights Heritage Center in Downtown Auburn and \$10,000,000 in construction funding through the URI Program; and

**WHEREAS,** upon receiving the Incentive Proposal and any related grant documents, the Mayor of the City of Auburn must be authorized to accept the grant funding and execute all necessary documents in connection therewith prior to commencing the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, that the Mayor of the City of Auburn is hereby authorized and directed to execute the Incentive Proposal, Grant Disbursement Agreement and all necessary documents with Empire State Development for advanced design documents and construction of the Equal Rights Heritage Center through an Upstate Revitalization Initiative Program grant in the amount of \$10,000,000 to be charged to the project capital account (HA 1620 440 IM) with revenue to be recognized into the Equal Rights Heritage Center State Aid Account (HA99.359.IM).

#### **AGREEMENT RESOLUTION #155 OF 2017**

#### AUTHORIZING THE MAYOR TO SIGN PARKING EASEMENTS

**WHEREAS**, the City of Auburn has developed and constructed public parking lots off Seminary Avenue and the Arterial East and in the process of establishing these parking lots the property rights and ownership of parcels and rights of way of adjoining property owners were eliminated; and

**WHEREAS**, the utilization of the buildings of the adjoining property owners of buildings located at 31,35 and 55 Market have been adversely affected by the loss of these property rights; and

**WHEREAS**, the Auburn City Council is desirous of restoring these property rights to the respective property owners who will be able to provide off street parking for the occupants of their buildings, namely:

31 Market Street owned by Unity House will be granted an easement over four (4) parking spaces at the rear of their building to accommodate two (2) buses and two (2) automobiles.

33 Market Street owned by Edward Meyer will be granted an easement over two (2) parking spaces at the rear of his building to accommodate two (2) automobiles.

55 Market Street owned by Kerstetter Apartments LLC. Will be granted an easement over eight (8) parking spaces at the rear of its parcel for automobiles used by its multiple tenants; and

**WHEREAS**, it is necessary that the Mayor be authorized to sign easements to allow for the parking for the properties set forth above.

**NOW, THEREFORE, BE IT RESOLVED**, that the Auburn City Council does hereby authorize the Mayor to sign easements and all other documents for recording the documents, granting the property owners of numbered 31, 35 and 55 Market easements at the rear of their buildings as follows: 31 Market Street parking for two buses and two automobiles; 35 Market Street parking for eight automobiles.
