Michael D. Quill, Mayor City of Auburn, New York **WHEREAS**, more than 50 years after the passage of the Equal Pay Act, women, especially minority women, continue to suffer the consequences of unequal pay; and

WHEREAS, according to the U.S. Census Bureau, women working full time, year round in 2009 typically earned 77 percent of what men earned, indicating little change or progress in pay equity; and

WHEREAS, according to *Graduating to a Pay Gap*, a 2012 research report by the American Association of University Women (AAUW), the gender pay gap is evident one year after college graduation, even after controlling for factors known to affect earnings, such as occupation, hours worked, and college major; and

WHEREAS, in 2009 the Lilly Ledbetter Fair Pay Act was signed into law, which gives back to employees their day in court to challenge a pay gap, and now we must pass the Paycheck Fairness Act, which would amend the Equal Pay Act by closing loopholes and improving the law's effectiveness; and

WHEREAS, according to one estimate, college-educated women working full time earn more than a half million dollars less than their male peers do over the course of a lifetime; and

WHEREAS, nearly four in 10 mothers are primary breadwinners in their households, and nearly two-thirds are primary or significant earners, making pay equity critical to families' economic security; and

WHEREAS, a lifetime of lower pay means women have less income to save for retirement and less income counted in a Social Security or pension benefit formula; and

WHEREAS, While New York State has the smallest gender wage gap in the country, women still only earn the equivalent of 89 cents to each man's dollar, and that number is even less for women of color. New York's Asian American, African American, and Hispanic and Latina women are paid 85 cents, 66 cents, and 50 cents, respectively, for every dollar earned by white non-Hispanic males.; and

WHEREAS, fair pay equity policies can be implemented simply and without undue costs or hardship in both the public and private sectors; and

WHEREAS, fair pay strengthens the security of families today and eases future retirement costs while enhancing the American economy; and

WHEREAS, Tuesday, April 10th symbolizes the time in 2018 when the wages paid to American women catch up to the wages paid to men from the previous year,

NOW, THEREFORE, I, Mayor Michael D Quill, do hereby proclaim Tuesday, April 10th, 2018:

EQUAL PAY DAY

In the City of Auburn and urge citizens to recognize the full value of women's skills and significant contributions to the labor force and further encourages businesses to conduct an internal pay evaluation to ensure women are being paid fairly.

WHEREAS, the City Council of the City of Auburn, New York (the "City") is considering undertaking the following project (the "Project"):

- a. reconstruction and resurfacing of various City streets, roads and parking lots including sidewalks, curbs, gutters, drainage, landscaping, grading or improving the rights of way not involving the addition of new travel lanes; and
- b. purchase of equipment to be used for constructing, reconstructing, repairing or maintaining City improvements, the cost of which is \$30,000 or more, for the City Departments of Public Works and Municipal Utilities; and
- c. renovation or reconstruction of various city owned buildings, whether or not including grading or improvement of the sites, original furnishings, equipment, machinery or apparatus required for the purposes for which such buildings are to be used; and

WHEREAS, the City desires to comply with the New York State Environmental Quality Review Act ("SEQRA") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being at 6 NYCRR Part 617, as amended (the "Regulations"), with respect to the Project; and

WHEREAS, the Project is determined to be a Type II Action, pursuant to 6 NYCRR \$617(c)(2)(4)(25), since it will entail the "replacement, rehabilitation or reconstruction of a structure or facility, in-kind, on the same site, including upgrading buildings to meet building or fire codes", as well as "repaving of existing highways not involving the addition of new travel lanes" and the "purchase or sale of furnishings, equipment or supplies..." and, therefore, no further review is required.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn hereby determines that the Project constitutes a "Type II Action" under 6 NYCRR § 617.5(c) (2)(4)(25), and, therefore, no further action under the SEQR Act and the Regulations is required; and,

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.

BOND ORDINANCE #3 OF 2018

AUTHORIZING THE ISSUANCE OF \$1,200,000 SERIAL BONDS TO FINANCE THE COSTS OF THE 2018-19 ROAD IMPROVEMENT PROGRAM, THE PURCHASE OF EQUIPMENT FOR THE PUBLIC WORKS DEPARTMENT AND CITY BUILDING AND GROUNDS IMPROVEMENTS

BE IT ORDAINED by Council of the City of Auburn, New York as follows:

<u>Section 1</u>. The City is hereby authorized to undertake the various capital projects described below at an aggregate estimated maximum cost of \$1,200,000, the estimated maximum cost of each Project being as follows:

(a) <u>2018-19 Road Improvement Program</u>. The reconstruction and resurfacing of various City streets and roads, including sidewalks, curbs, gutters, drainage, landscaping, grading or improving the rights of way, with a pavement which will be more durable construction than pavement of sand and gravel, water-bound macadam or penetration process with single-surface treatment at an estimated maximum cost of \$400,000 and to issue an aggregate \$400,000 in serial bonds pursuant to the provisions of the Local Finance Law to finance the estimated costs of the aforesaid object or purpose.

- (b) <u>Equipment for Public Works Department</u>. The purchase of equipment to be used for constructing, reconstructing, repairing or maintaining City improvements, the cost of which is \$30,000 or more, including but not limited to two small plow trucks, a bucket truck, an electric forklift, and a truck with a lift for the City Department of Public Works at an estimated maximum cost of \$380,000 and to issue an aggregate \$380,000 in serial bonds pursuant to the provisions of the Local Finance Law to finance the estimated costs of the aforesaid object or purpose.
- (c) <u>City Buildings and Grounds Improvements.</u> The renovation or reconstruction of various city owned buildings, whether or not including grading or improvement of the sites, original furnishings, equipment, machinery or apparatus required for the purposes for which such buildings are to be used at an estimated maximum cost of \$420,000 and to issue an aggregate \$420,000 in serial bonds pursuant to the provisions of the Local Finance Law to finance the estimated costs of the aforesaid object or purpose.
- <u>Section 2</u>. It is hereby determined that the maximum estimated cost of the aforesaid specific objects or purposes is \$1,200,000, said amount is hereby appropriated therefor and the plan for the financing thereof shall consist of the issuance of \$1,200,000 in serial bonds (the "Bonds") of the City authorized to be issued pursuant to this Ordinance.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific objects or purposes pursuant to paragraph 4 of Section 11.00(a) of the Local Finance Law are as follows:

<u>Section 4</u>. Pursuant to Section 107.00(d)(9) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

<u>Section 5</u>. The temporary use of available funds of the City, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this Ordinance.

Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the City, payable as to both principal and interest by a general tax upon all the real property within the City without legal or constitutional limitation as to rate or amount. The faith and credit of the City are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the City by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this Ordinance and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to issue bonds providing for level or substantially level or declining annual debt service, is hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.

Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this Ordinance shall be from the City's General Fund. It is intended that the City shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this Ordinance and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This Ordinance is intended to constitute the declaration of the City's "official intent" to reimburse the expenditures authorized by this Ordinance with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Treasury Regulation Section 1.150-2. Other than as specified in this Ordinance, no moneys are reasonably expected to be received, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

<u>Section 9</u>. The serial bonds and bond anticipation notes authorized to be issued by this Ordinance are hereby authorized to be consolidated, at the option of the City's Comptroller, the Chief Fiscal Officer, with the serial bonds and bond anticipation notes authorized by other Bond Ordinances previously or hereafter adopted by the City Council for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such ordinances. All maters regarding the sale of the bonds, including the date of the bonds, the consolidation of the serial bonds and the bond anticipation notes with other issues of the City and the serial maturities of the bonds are hereby delegated to the City Comptroller, the Chief Fiscal Officer of the City.

<u>Section 10</u>. The validity of the Bonds authorized by this Ordinance and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the City is not authorized to expend money; or
- (b) the provisions of law which should be complied with at the date of the publication of this Ordinance or a summary hereof are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or
- (c) such obligations are authorized in violation of the provisions of the Constitution.
- Section 11. The City Comptroller, as Chief Fiscal Officer of the City, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the City to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12.
- <u>Section 12</u>. This Ordinance, or a summary of this Ordinance, shall be published in the official newspapers of the City for such purpose, together with a notice of the Clerk of the City in substantially the form provided in Section 81.00 of the Local Finance Law.
 - <u>Section 13</u>. This Ordinance is not subject to a mandatory or permissive referendum.
- <u>Section 14</u>. The Council hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Ordinance.

<u>Section 15</u>. This Ordinance shall take effect immediately upon its adoption.

COUNCIL RESOLUTION # 57 OF 2018

CITING NEGATIVE REGIONAL ENVIRONMENTAL AND ECONOMIC IMPACTS OF THE PROPOSED WASTE INCINERATOR IN THE TOWN OF ROMULUS, SENECA COUNTY AND OPPOSING THE PROJECT

WHEREAS, a recently formed company named Circular enerG, LLC has proposed building the largest garbage incinerator in New York State in the Town of Romulus, Seneca County, squarely

between Seneca and Cayuga lakes, the two largest of the Finger Lakes and west of Cayuga County (the "Project"); and

WHEREAS, as proposed, this Project has a plan to import up to 2600 Tons of Solid Waste, per day, at full buildout, which is roughly three times (3x) the municipal solid waste imported to the OCRRA/COVANTA waste incinerator in the Town of Onondaga, Onondaga County, east of Cayuga County; and

WHEREAS, the waste incinerator Project is proposing to bring up to 238 trucks into the region per day, hauling 20-30 tons of garbage each, from long distances six days a week, which equates to 148,512 additional trucks per year ultimately entering and leaving the facility and it is likely that some, if not many, of these trucks will be routed through Auburn and Cayuga County and the surrounding region thereby increasing traffic and road impacts to our roadways; and

WHEREAS, the waste incinerator Project is proposing rail transport operations that would include rail deliveries of 30 flat railcars carrying 120 sealed containers Monday through Saturday each week and it is likely that these rail transports will need to travel via the rail tracks that run through the City of Auburn increasing the rail traffic experienced in the City; and

WHEREAS, the proposed Waste Incinerator will include a 260-foot smokestack through which emissions of the waste incineration process will pass, emissions that in addition to carbon dioxide and water vapor may also include byproducts such as soot particles and other contaminants released in exhaust gases, leaving a residue (bottom ash) of incombustible and partially combusted waste, creating up to 1 ton of toxic ash for every 4 tons of waste that is burned which would require trucking through local communities for landfilling; and

WHEREAS, the exhaust gases from the waste incineration Project may contain many potentially harmful substances, including particulate matter; oxides of nitrogen; oxides of sulfur; carbon monoxide; dioxins and furans; metals, such as lead and mercury; acid gases; volatile chlorinated organic compounds; and polycyclic aromatic compounds; and

WHEREAS, for such metals and other pollutants that are very persistent in the environment, the potential effects may extend well beyond the area close to the incinerator because persistent pollutants can be carried long distances from their emission sources, go through various chemical and physical transformations, and pass numerous times through soil, water or food; and

WHEREAS, Auburn and Cayuga County, including Owasco Lake and Cayuga Lake along with both of their watershed areas, is due east and downwind of the proposed Circular enerG waste incinerator Project and the prevailing winds will very likely disperse the emissions from the incinerator across municipal boundaries, into our communities and onto our watershed land; and

WHEREAS, the Finger Lakes are a nationally recognized tourist destination attracting millions of visitors annually to its local wineries, breweries, restaurants, farms and other tourist attractions; and

WHEREAS, a considerable increase in the import of trash and municipal solid waste for local incineration is not compatible with current or future economic development goals of the region and could very well endanger the growth and vitality of the Wine, Agricultural and Tourism sectors, including these sectors in Auburn and Cayuga County; and

WHEREAS, the boundaries of an area potentially affected by a waste incinerator should not be defined at the outset by a particular community's political boundaries or jurisdiction, but instead, the assessment area should be based on the geographic extent over which various effects could reasonably occur; and

WHEREAS, the Auburn City Council believes that the proposed Project would result in negative environmental and economic impacts within the Finger Lakes Region and that these negative impacts may extend well beyond the municipal boundaries of the Town of Romulus and Seneca County and could very well extend into Auburn and Cayuga County;

NOW, THEREFORE BE IT RESOLVED, by City Council of the City of Auburn that:

- The City of Auburn opposes the waste incinerator proposed by Circular enerG to be constructed in the Finger Lakes in the Town of Romulus, Seneca County and urges the Town of Romulus to stand in opposition to the Project and calls on Governor Andrew Cuomo and his administration to reject the Circular enerG Waste Incinerator proposal; and
- 2. The City Clerk is hereby authorized and directed to send certified copies of this Resolution to Governor Andrew Cuomo; New York State Assembly Speaker Carl Heastie; New York State Assembly Minority Leader Brian Kolb; New York State Senate Majority Leader John Flanagan; New York State Senate Democratic Conference Leader Andrea Stewart-Cousins; New York State Senate Independent Democratic Conference Leader Jeffrey Klein; State Senators Pam Helming, John DeFrancisco, and James Seward, Assembly members Gary Finch, Robert Oaks; US Senators Charles Schumer and Kirsten Gillibrand; Congress Member John Katko; NYS Dept. of Environmental Conservation Commissioner Basil Seggos, NYS Public Service Commissioner Chair John Rhodes, NY State Dept. of Agriculture and Markets Commissioner Richard Ball, NYSERDA Chair Richard L. Kaufman, NYS Empire State Development Commissioner Howard Zempsky, NYS Department of Health Commissioner Howard Zucker, Romulus Town Supervisor David Kaiser, Romulus Planning Board Chair Tom Bouchard, and Seneca County Board of Supervisors Chair Robert Shipley; and
- 3. This resolution shall take effect immediately.

RE: 2018-19 Preliminary Budget

Background:

City staff has been diligently working on preparing this budget in accordance with the budget timeline adopted by the City Council. Please see the attachments for the details of the proposal, below are highlights of this year's budget. As always, please keep in mind that we will be modifying estimates as better numbers become available as budgeting is based on educated estimates and not specifically know figures.

General Fund:

The total General fund budget is projected at approximately \$34,287,715 which is a 1.0% increase from the prior year. There is no use of fund balance included in the proposed budget and the proposed tax levy increase is set at 5.00%. This is the growth factor published by NYS for the

City's fiscal year. Below is a highlight of significant changes in total department budgets that lead to the overall increase of 1.0%. Department heads will provide a more detailed look at their departments' budget.

Emperication Changest
☐ City Manager - The transfer of the Director of Capital Projects from Planning.
□ Corporation Counsel – The part time Corporation Counsel is retiring.
☐ Engineering – Purchasing a LG formatted printer and staff changes.
□ Public Works Garage – Purchasing a tire mounting machine to replace the obsolete one
that is over 20 years old and replacement parts cannot be found.
☐ Unallocated Salaries – This line decreased as it holds a contingency for contract
negotiations which have all been settle this year.
□ Central Services – Purchase of a new network switch, updates to Munis and new Cloud
backup.
□ Police – Purchasing four new SUVs which after use for a few years will be transferred to
other departments for use.
☐ Municipal Parking – Adding a full time laborer who will be tasked with maintaining the
Parking Garage as well and help as needed in the new Visitors Center.
□ Falcon Park – Purchasing a new infield groomer to replace a ten year old one.

□ Contractual Salary Increases
☐ Health Insurance – The move to the Cayuga County Health Insurance Consortium allows
the City to be able to budget known costs and therefore can reduce the contingency previously budgeted in this account. Projects saving of \$350k from last year.
Revenue Changes:
☐ State revenues for AIM funding, CHIPS funding, PAVE NY funding and arterial highway
maintenance funding have been budgeted at amounts proposed in the Governor's FY2018-19 budget. These revenue line items may be adjusted once a final State budget is released.
□ Sales tax has been increased 2% based on year to date information compared to last year.
☐ The vacant building registry fees are escalating this year; this is a set escalation depending
on when the building became vacant.

Landfill Fund

The fund is balanced on a cash flow basis with no fee changes to citizens. The fund budget has decreased by 4.1% due to the retirement of two long term employees and a decrease in the transfer to the General Fund.

Refuse Collection Fund

The fund has a 3.1% increase due to contractual salary increases and debt payment increases. The

fund is balanced without the need for fee increases but a small use of fund balance.

Power Utility Fund

There is a large increase of 28.2% in this fund's budget due to the new \$3.6m debt issuance for the Mill Street Dam Hydro Electric Facility. The fund is balanced after a \$300k transfer from the general fund.

Water Fund

The fund has an overall fund increase of 2.6% due to contractual salary increases and debt payment increases. The fund is balanced without the need for fee increases or use of fund balance.

Sewer Fund

The fund has a slight .6% increase due to contractual salary increases and new debt issuances. The fund is balanced without the need for City user or wholesale customer fee increases or use of fund balance.
