Mayor Quill announced that the PUBLIC HEARING CONCERNING THE CITY MANAGER'S RECOMMENDEDBUDGET FOR 2018-2019 was now open. The following individual spoke:

**Donna Lamb, Executive Director of the Schweinfurth Memorial Art Center made the following statement:** I am here tonight to offer my enthusiastic support for the inclusion of \$20,000 in the budget targeted for public art funding, specifically for developing an arts and

entertainment district.

Auburn has been identified as one 5 pilot communities to benefit from planning assistance through a \$100,000 grant from the Empire State Development Corporation in partnership with the Regional Economic Development Council for Phase I Master Planning to create Arts and Entertainment Districts in Auburn, Cortland, Oneida, Oswego and Syracuse. The project is administered through CNY Arts, our Central New York Arts Agency. The goal of this project is to increase attendance at arts and entertainment venues, as well as the local hospitality industry. This will positively impact local economies by generating jobs and income for the arts and entertainment venues and those businesses servicing the district.

I am told by CNY Arts that Auburn is one of the 3 cities ready to move forward. The funding allocated by the City will help us leverage assistance provided by the CNY arts project to advance our project. Implementing an arts and entertainment district has long been a goal here in Auburn. With help from the CNY Arts grant in the planning, the budget allocation from the city, and the potential for funding through a downtown revitalization grant, the time has never been better to move forward in establishing as arts and entertainment district.
