A child going to bed hungry; and trying to concentrate in school with an empty stomach is, in my opinion, not going to get much pleasure out of a grandiose playground. Far better to set up new or improved soup kitchens to feed children and parents. A new name would be nice, such as food distribution centers are little easier to swallow., no pun intended. Set up

four centers, one north, one south, one east and one west to make them easier to get to. Your graduation rates will go up, and possibly your crime rates will go down. Folks with something in their bellies won't have to rob to get money to buy food. Think about it.

AWARDING A BID FOR THE PURCHASE OF ULTRAVIOLET DISINFECTION EQUIPMENT FOR THE WASTEWATER TREATMENT PLANT

WHEREAS, on March 15, 2018, the Auburn City Council passed Bond Ordinance #2 of 2018, which authorized City Staff to undertake the construction/reconstruction of improvements to the City's Wastewater Treatment Plant including the ultraviolet disinfection system; and,

WHEREAS, on August 20, 2018, the City opened bids for the purchase of ultraviolet (UV) disinfection equipment and the following bids were received:

WHEREAS, the bids submitted by Glasco Ultraviolet, LLC and Wedeco were deemed non-responsive since those bid equipment specifications failed to satisfy the technical requirements necessary for regulatory compliance; and

WHEREAS, the City's consultant, GHD, has reviewed the bids received and has recommended awarding the bid to Suez

Treatment Solutions, Inc. since their bid was responsive with the highest best value score; and
