- M. Carlisle to ask Jim Garreffi, Director, Nashoba Associated Boards of Health, if their fees for Ayer have increased.

Spinner stated she saw a public hearing notice in the newspaper for 20 Fletcher St. The property owner is appearing before the Zoning Board of Appeals to request a variance for adding an addition to the home. This property is located in the Zone II of the Aquifer Protection District for the Grove Pond wells and requires a Special Permit or a review from the Board of Health. M. Carlisle to check with Sue Sullivan from Zoning.
 - M. Carlisle to draft a letter and give a copy of the Aquifer Protection District map to Planning, Zoning and the Building Inspector asking them to advise this board of any construction taking place in the designated Zone II.
