• Discussion: Sandy Pond School House Restoration Project

- o Irving Rockwood, Vice President of the Sandy Pond School Association, gave an update on progress since CPC's last meeting with the Association on 4/1/15.
- o Article 26
 - Article 26 on the Warrant for Spring Town Meeting (5/11/15) is a motion to approve \$5000 in one-time funding to aid the Association in completing its National Register nomination.
 - If Article 26 passes, the consultant who has already worked with the Association will be ready to quickly move forward on this project following execution of a grant agreement with the Town.

Potential CPA projects

- The Association has been seeking quotes for an overall comprehensive structural analysis of the School House and related projects.
 - One quote is already in hand and a second is on the way.
 - Because historical restoration involves specialized vendors, Mr.
 Rockwood said it will take some time to find a third qualified vendor.
- The Association is also starting to look for vendors capable of doing restoration work on the ceiling.
 - The ceiling, made of horsehair plaster, is original.
- JP clarified that projects using CPC funds will need 3 quotes before signing an agreement with a vendor for any type of work, but that these quotes do not need to be secured prior to completing the CPC application process.
- o BAS said she would like more discussion in the future on ways to increase public access to the property, especially if Town funding is used toward its improvement.
 - In such case, the DPW could also perhaps help with ground maintenance.
- Mr. Rockwood spoke of the need for the Association to first develop an annual operating budget before it can explore future proposals.
