- o Confirmation of Agenda
 - o GB moved to confirm agenda as posted; TT 2nd.
 - Motion approved unanimously.

O Discussion: Proposed chicken coop, 72 Snake Hill Road.

- o Peter Hartkopf and Huyen Nguyen were present.
- o They plan to build or install a prebuilt chicken coop for 10 chickens on their property.
- o BD said ConCom's concern was the steep slope of the backyard to the fence, beyond which lie a detention basin and wetlands.
 - During heavy rains, fecal waste from the coop must be prevented from flowing into the wetlands.
- o Mr. Hartkopf said he planned to dig a pit barrier filled with sand and brick.
 - BD suggested a curved earthen berm instead
 - The distance between the fence and the berm should be 5-10 ft., and between the berm and the coop another 5 to 10 ft.
- o Mr. Hartkopf and Ms. Nguyen were asked to submit an RDA.
- The application drawing should indicate the location and dimensions of the coop, and the actual distances planned between fence, berm and coop.
- o CA will also contact the BOH to inform them that our permitting process is underway and that, from ConCom's perspective, the BOH can go ahead and issue its permit.

CA Updates

- o CA will be contacting Sandy Pond Road resident Keith Henderson.
 - Mr. Henderson has safety concerns with some tall pine trees in his yard.
 - Mr. Henderson was asked to ribbon off the trees he would like to cut down.
 - CA will perform a site visit.
- CA received a request from Alex Woodle, of Groton.
 - Mr. Woodle is part of a pond association which is seeking approval to use Sonar in weed treatment on some of Groton's ponds.
 - The use of Sonar is opposed by some.
 - Mr. Woodle asked if a representative from Ayer ConCom could attend the NOI hearing with Groton's ConCom at 7 p.m. on 10/9 to be available to answer questions about Sonar if necessary.
 - TT volunteered to do so.
