- Meeting Minutes Approval
 - JG moved to approve 06/12/08 meeting minutes, with minor edits; DB 2^{nd} .
- Payables
 - o Grafax invoice in amount of \$125.00
 - For printing of pond informational letter, 125 double-sided color copies.
 - DB moved to pay Grafax invoice, from pond weed control funds; JG 2nd.
 - Motion approved unan.
 - Lowell Sun invoice in amount of \$93.50
 - For legal ads for 2 Wright Way and 9 Bishop Road. CA received payment from both applicants.
 - JG moved to pay Lowell Sun invoice; DB 2nd.
 - Motion approved unan.

• Public Hearing: NOI – 12 Willow Road (Hybricon)

- Eric Rudenauer of GPR, representing Daniels Island Enterprises LLC.
- Mr. Rudenauer submitted legal ad payment and copies of certified mail green cards.
- Project involves abandoning the existing septic tank and installing sewer pipe and pump station to tie-in to Town wastewater infrastructure along Willow Road.
 - All work will occur within the existing disturbed area on the Hybricon lot.
 - Pump station will be located within the existing septic tank footprint.
 - Catch basins will be protected with mesh fabric during construction.
 - Project plans were submitted to DPW and BOH for review.
- CA conducted site walk to review the proposed work no issues to report.
- GB moved to approve NOI application for 12 Willow Road; DB 2^{nd} .
 - Motion approved unan.
- DB reminded Mr. Rudenauer to have haybales inspected by CA before starting work.
- GB moved to continue hearing to 07/10/08; DB 2^{nd} .
 - Motion approved unan.
- CA to prepare OOC and Special Conditions.

• Public Hearing (cont'd): RDA – Boston & Maine Railroad

- Mr. Keith Morris was not present.
- Project involves application of herbicide along the right-of-way, from Nemco Way to Littleton Town Line.

- Herbicide to be applied is Roundup, at low concentrations.
- GB and JG attended site walk with Mr. Morris no issues to report.
- \circ GB moved to approve a 'negative' determination for B&M Railroad; DB 2nd.
 - Motion approved unan.

• Public Hearing (cont'd): OOC Extension – Crabtree Development (Ridge View Heights)

- Received written request for extension of Lot 70-A (DEP # 100-0278) and Lot 134 (DEP # 100-0276).
- DB moved to approve 3-year OOC extensions; JG 2^{nd} .
 - Motion approved unan.

• Public Hearing: COC – 1 Pheasant Circle (Lot 1-A, DEP # 100-0289)

- Request for COC on Lot 1-A by Canney Bros. LLC, not present.
- o BD walked the site back in April as part of the 82 Groton School Road project.
- CA also walked the site for Pheasant Circle residents Nix and Stiles.
- DB moved to issue COC for Lot 1-A, Pheasant Circle; GB 2^{nd} .
 - Motion approved (4 aye; 1 abstain)

• Discussion: Violation Notice – 88 Central Avenue

- DB will draft a Violation Notice for Mr. Coke, 88 Central Ave., for unauthorized activities within the wetland buffer zone.
- Discussion: Chapter 91 Mailing for Pond Abutters
 - Janet Berube has been assisting CA with preparation of mailings.
 - CA provided examples of the mailings that will be sent out.
 - Includes information on Ch. 91 and the pond weed control pamphlet.

• Discussion: Pond Weed Control – Scope of Work for Weed Monitoring

o BD sent written request to Town for 'rollover' of approved weed control funds into FY09.

• Discussion: Creation of Private Beaches

- o Several residents on Sandy Pond and Flannagan Pond have created artificial beaches.
- o How should Commission handle existing and future beach projects?
- o Commission will consult J. Gensel, Central Region Wetlands Circuit Rider, for advice.
- Discussion: Icehouse Partners (Ice House Dam)
 - o Do they need to file RDA or NOI for annual dam inspection?
 - CA will contact Ann Gagnon to see how Shirley is handling this issue.

• Discussion: Monthly Meeting Schedule, Oct.-Dec. 2008

- o Commission discussed potential scheduling conflicts in the latter part of 2008.
- Potential conflicts include Yom Kippur, Thanksgiving, and Christmas.

• Discussion: Ayer Stormwater Bylaw

- Although the Stormwater Bylaw was approved at ATM, its implementing regulations have yet to be codified.
- DPW wants to continue convening the Stormwater Committee to assist in development of the regulations.

• Announcements/Other Issues

- The updated Devens Open Space/Recreation Plan has been finalized and signed.
- Shaker Hills Golf Course provided a copy of its Groundwater Sampling Report.
- o JG: There is a certified wildlife veterinarian in Lunenburg.
- GB: MassWildlife held a meeting re: wildlife survey of North Post.
 - Survey found many rare and endangered species.
 - TT will request a copy of the report from MassDevelopment.
- o GB: CA's weekly hours for FY09
 - CA will have 10 hours/week under the regular budget line item.
 - CA will also have 4 hours/week under the Stormwater Bylaw line item. However, these funds may not be available until the implementing regulations are in place.
 - In the interim, may cover the 4 hours/week from Wetlands Funds.
 - GB moved to fund 4 hours/week from Wetlands Funds, through 09/26/08; DB 2nd.
 - Motion approved unan.
- o CA: Prioritization of tasks
 - File organization, with assistance from J. Berube.
 - Permit tracking, especially those issued in 2005 and 2006.
 - Informational kiosk packet.
- GB moved to adjourn; DB 2nd.
 - Motion approved unanimously.
