- New England Power Company will be conducting routine weed treatment in 2009 along its powerlines.
 - CA will ask Board of Health if there are any private wells near powerlines.
- BOS sent reminder to boards re: procedure for locking doors and turning off lights at Town Hall.
- Surface Transportation Board sent memo to Town re: Environmental Assessment of joint operation agreement between Guilford/PanAm and Norfolk Southern.
 - Deadline for comments is 12/15/08.
- Public Meeting (cont'd): RDA for Temporary Dock Permit 2 Wright Way
 - Keith Henderson, 2 Wright Way, presented his revised plan for a temporary dock permit.
 - He added the rock wall and beach nourishment area to the plan.
 - GB moved to issue a Negative Determination for Mr. Henderson; $JG 2^{nd}$.
 - Motion approved unanimously.

• Public Hearing: OOC Extension for Pond Weed Control – Ayer Conservation Commission

- The Town's permit (DEP #100-0293) for pond weed control expires 2/9/09.
- CA: The file does not contain a recorded copy of the OOC.
 - Will contact ACT to see if they have a recorded copy.
- GB moved to extend the OOC for three years (2/9/12); JG 2^{nd} .
 - Motion approved unanimously.

- There is hunting access, and possibly tree removal or other activities occurring.
- CA will send a letter to Mr. Moulton.
- Violation Notice for hydroseeding company: pending (BD).
- Chapter 91 meeting, scheduled on 12/10/08, had to be canceled due to lack of meeting space in Town Hall.
 - CA will reschedule sometime in January 2009.
- TT: The ACEC program only reviews projects if they are within an ACEC and if they meet MEPA review thresholds.
- CA: the next meeting will include:
 - COC request from Hybricon.
 - NOI application from Crabtree Development (Pingry Hill/Ridgeview).
 - COC request from Crabtree Dev.
 - There may be unresolved siltation issues at the site.

• Discussion: Pond Weed Control Contract with ACT

- BD believes ACT has satisfied all of its contractual obligations, including post-treatment monitoring and reporting.
 - BD summarized ACT's weed control activities to date.
- Water-lilly and bladderwort are native species, while robin's pondweed is considered beneficial.
- Patrick Hughes has issues with the handling of the contract and has requested a meeting with BOS. Mr. Hughes also would like to revisit the procedure for lowering the ponds (removal of boards at Balch Pond Dam).
- o JG: Pond water levels are also influenced by heavy rain events.
- Dominic Meringolo of ACT will attend the 2/12/09 Conservation Commission meeting.
