- Stephanie Gietner, Treasurer presented a Reserve Trust Transfer in the amount of \$14,500 for Unemployment Insurance
 - o BM Why was the budget line off so mush
 - o SG The budget was set by my predecessor. The budget may have been set at .02% instead of the adjusted .03% which is the new amount.
 - BM Lisa Gabree reviewed the budget and found the calculation for FY2011 was wrong. The budget for FY2012 should be correct.
 - SG In 2009 the payment for unemployment was split from state tax. The caused a problem with the calculation and payments. The payments had to be in separate files and transmitted. However, the site would only accept one file at a time.
 - SH Is the \$14,500 a correct estimate? Are we sure that we will not be transferring more than is needed?
 - CS I would prefer to transfer the \$3,052 which is the known expense.
 - o BM There will be line item transfers in July to move budget money. I would prefer to give the \$14,500.
 - o Motion to transfer from Reserve Fund the amount of \$3,051.79 to account 01913-51710 for unemployment tax

- O Stephanie Gietner presented a RFT in the amount of \$2,865.00 for Tax Title Expense.
 - The invoice is due at the end of June. Stephanie is waiting for details from the lawyers handling Tax Title for the final amount due for FY2011. The RFT will be delayed until the June 22 meeting.
- Stephanie Gietner presented a memo from Middlesex County Retirement that the assessment will be lower for FY2012. This will create a surplus of approximately \$6,000. The treasurer requests that the part time person reduced in the FY2012 budget be reinstated. The Committee will discuss at the June 22 meeting.
- Chief Bob Pedrazzi presented a Reserve Fund Transfer in the amount of \$48,160.
 - BP All employees are back to work at the fire station. The breakout of the \$48,160 includes wages, call pay, overtime, and full time call back. There is an insurance payment of \$10,571.43 to offset the expenses. There is a remaining 111F claim the town is pursuing legal action on the insurance company. The 48,160 is needed for the mid-month payroll.
