  - b. Town Administrator Search had 5 candidates forwarded to BOS for their review.
- 14. Compensation CD for Massachusetts from MMA has not arrived to date
- 15. Energy Committee Update
  - a. Some departments utilize remaining FY2010 funds to upgrade energy efficiency.
  - b. \$150,000 grant was received by Town of Ayer from State for Green Initiatives. This money may be used towards UV system at DPW waste water treatment plant.
  - c. If DPW usage is not within guidelines, the money may be used for Town Hall efficiency measures.
  - d. Johnson Controls has not presented Energy Committee with school audit as of this date.
  - e. There continues to be discrepancies with contract proposed by Johnson Control for Town of Ayer. Energy continues to push for verbiage specifying Johnson Controls be responsible for post upgrade responsibility regarding Handicap accessibility.
  - f. JR 20% cut in green house gas emissions output allows Ayer to become a "Green Community" and eligible for additional state grants for energy efficiency.
