 - o Summary report presented for new member of the FY2012 budget

 - o Committee agrees to wait for more information until a member can commit.
- Ayer Shirley Regional School Committee leadership committee has been established and appointed
 - o Ayer representatives are Dan Gleason, Bob Prescott, Evan Katz, Robert Pontbriand, Lisa Gabree, Brian Muldoon.
- Vicksburg Square
 - o JK What is FinCom's role with VB?
 - BM Vote on the warrant at town meeting
 - SH The concerns are the housing type and the tax impact on the town.
 - o PC The school population is half of what the original estimate was.
 - SH \$1.3m in expense with only \$400,000 in tax revenue,.
 - o BM I have asked Victor Normand to a FinCom meeting. Victor is from Harvard and headed the Devens Economic Analysis Team (DEAT). The committee was established by the Harvard Board of Selectmen,
 - PC DEAT is scheduled to report to the Harvard BOS on Sept 20th.

- JK First session was last night. Methodology was discussed. Certain line items will not change on some departments due to contract obligations.
- o BM Testing departments?
 - JK Discussion is to do all
 - PC The next meetings will be biweekly. The group should have something together for Fall Town Meeting.

• Delinquent Taxes

- o BM Is there a policy about posting delinquent taxes publicly? As mush as I know there is none set. They are generally on the bulletin board
- o The original amount FinCom was given in the spring was \$289,000. there have been payments since then and the current amount is approximately \$87,000.
- o MP I propose that the committee request to publish the delinquent taxes. The tax collector should publish locally on the website and in the paper. This should include all water and sewer bills.
- BM What is the definition of delinquent? The tax collector must decide.

Rates and Fees

- MS Certificates and Fees have not changed in ten years.
- o BM A rates and fees study was requested by the town administrator. The rates and fees are generally done in August. Robert is compiling.
- o JR Who sets certificates; BOS or clerk?
 - MS It should be the clerk with the push of the BOS.
 - PC Certificates come from the clerk and licenses from the BOS. There needs to be a communication line.
- o BM Let's start with an email to the clerk asking about the certificate process. Rates and fees should be reviewed by the rates and fees committee.

Weed Control

- O SH There was a proposal to Community Preservation to for \$35,000 of CPC funds be used to fund Article 38 from Spring Town Meeting. The article was passed after the budget was set and therefore the budget is unbalanced. We will need to find a funding source at the fall town meeting.
- o MP According to the assessors, Chuck Miller owns lot 40 which goes into the pond. Lot 48 which makes up 40% of the private land under the pond has been paying taxes up through 2010.
- o PC Harvard uses CPC funds for Bear Hill Pond to preserve and protect the pond. Rather see CPC funds used rather than require cuts elsewhere in the general budget.
- o MS Dam management committee with DPW will have an impact. If the dams remain closed in the warmer months the water level will stay higher and slow the growth of weeds.
