## Reimbursement Bills

Jim and David both had receipts for expenses for the Dance. The motion and second was passed to pay them. As it turned out, Jim did not turn in the correct receipt which was caught the next day and David turned in a second receipt. In all there were three receipts turned in for payment.

## 4/30/2013 Election

Money was turned over to the Treasurer for the Mother's Day and Father's Day Basket raffle ticket sales. The total turned over was $\$ 646$. It was at first divided in half for each on the spreadsheet. We discussed which basket made the most money. The only way to determine that is to count the tickets. Ruth Rhonemus volunteered to count the tickets. The count came in as Mother's Day - 406 tickets and Father's Day - 233 tickets. There was $\$ 50$ in donations. After subtracting that from the total and figuring out the percentages, the MD was $63 \%$ and the FD was $37 \%$. Those were applied to the Net Total and entered on the spreadsheet.
