Jim will check with DES permit archives in reference to most recent mining permits granted in Barrington. Discussion about what date to use in ordinance; 2005, when the master plan was changed was suggested.  
The ordinance will be wrapped up by the end of October.

Come up with strategies to get the Ordinance to Barrington Residents.

- 1) We will present the ordinance to the Conservation Committee at their meeting in November to get their endorsement. John Wallace will put us on the agenda.
- 2) In the middle of November we will present the ordinance to our Selectmen. We will invite Mark Carpenter, Selectman of Nottingham and Barnstead Selectman Gordon Preston to come to this presentation. Gail will contact Mark and Gordon.
- 3) We will try to get on the November Agenda of the Advocates for a Better Barrington and present the ordinance to them. They do a town wide mailing; maybe we can get a write up in that.
- 4) Present it to the Isinglass Local Advisory Committee (Ann Melvin) Find out time and place of meetings and ask to be put onto their agenda.
- 5) Present it to the Tax Payers Association. Find out time and place of meetings.

- 6) Present it to the Barrington Chamber of Commerce. Find out time and place of meetings and ask to be put on their agenda.
- 7) Post the Ordinance in the Town Hall, the Post Office, the Library and at the Schools where town meetings are held.
